Western Dressage is being offered as a trial supplemental class to gauge interest. No state qualifying points will be given for placing. Therefore, it does not count towards the 5 class maximum. CONTESTANT MAY ENTER 5 CLASSES and WESTERN DRESSAGE.

Before you fill out the Entry Form, consult the OFFICIAL RULES if you have any questions about the requirements or procedures for any class. PLEASE NOTE: The rules for Junior and Intermediate classes have changed:

- Juniors are 8-10 as of September 1 of the current 4-H year.
- Intermediates (11-13 as of September 1 of the current 4-H year) have the option of competing in either the Junior or Senior division. Intermediates may qualify for Regionals provided they compete and qualify in the Senior Division in both the Area and State shows. Intermediates who do not wish to compete for potential qualification for Regionals should enter the Junior division at the Area show. Juniors, and Intermediates competing at the Junior level, will not be permitted to participate in competition beyond state level.
- Seniors must be 14 years old on or before September 1st of the current 4-H year.

Each contestant should enter the proper class according to age of contestant, age of horse, and height of horse. Ponies will be measured upon check-in at the Area F 4-H Horse Show. No class changes will be allowed except in instances where horse/pony height requirements are not met. County agents should check and verify the correctness of entries before signing.

The show will be held on the date scheduled barring a natural catastrophe. It is the responsibility of the exhibitors' parents or guardians to determine if they are able to compete safely. In case of inclement weather, all contestants should realize that the conditions and facilities are the best available as determined by the show management and must accept these conditions and show accordingly.

Parking

Parking will be in specific locations. There will be assistance on Friday with this. We need to park in certain areas as we will be allowing people to skip a stall and use their trailer that day. Thus we are going to have the trailers away from the stalls.

Coggins (Required with Registration)

All horses are required to submit a copy of the original coggins with registration forms. Upon arrival, the coggins on record will be checked by a state inspector to ensure it matches the horse competing in the show.

Shavings

Per Jim Brandon Equestrian Center policy, participants are NOT permitted to bring their own shavings. All participants who are stabling will receive 2 bags of shavings from the showgrounds. Additional bags may be purchased at \$7.00 per bag.

Stall Deposits & Stall Cleaning

If you would like to pre-arrange to have your stall cleaned for you, please include \$25.00/stall in your entry fee. If you plan to clean your stall yourself, you will be required to submit a \$25.00/stall deposit. This deposit must be a check (separate from your entry fee) made payable to **Broward County 4-H Association**. You may submit the stall deposit check with your registration paperwork to your county 4-H program, or submit the deposit check upon check-in at the showgrounds. The deposit check will be returned to you upon check-out from the show once your stall has been inspected. In the event that you leave without cleaning your stall, the deposit check will be cashed.
