REGULAR BUSINESS - ACTIONS OF MEETING

Agenda Item: 3.A. Adoption of CAC Regular Committee Minutes (March 8, 2018)

<u>Discussion</u>: The noted date of the CHIP meeting has changed but it was accurate as of the date of the previous meeting.

<u>Action Taken</u>: Motion to approve the minutes by Elizabeth Hernandez Cayson. Second by Barbara Jacobowitz. Minutes approved and adopted by unanimous vote.

REGULAR BUSINESS

Agenda Item: 3.B. FAA RFP Update (Meghan Parnell)

- Meghan Parnell gave a brief overview of the RFP timeline and mentioned that the recommendations will most likely go before the Board of County Commissioners (BCC) on June 19, 2018.
- Ms. Parnell restated the priorities for Domestic Abuse / Sheltering and Homelessness.
- Taruna Malhotra noted the department's request for a 3% increase but added that the budget has not been approved yet.
- There was general discussion to clarify that agencies not being funded did not address the identified priorities.

- Ms. Malhotra mentioned the possibility of funding additional agencies if the department receives a budget increase.
- Ms. Malhotra also added that if one of the additional agencies that serves a specific population is funded, it would be recommended to be moved to a different service category.
- Members of the Citizens Advisory Committee (CAC/HHS) expressed their support for a 3% budget increase.
- Helene Hvizd reiterated the CAC's role as a strictly advisory committee and mentioned that although
 it is important for their voice to be heard, they would have to do so during the Public Comments section
 of the BCC meeting in June.

Agenda Item: 3.B. FAA RFP Update and Support from CAC/HHS

Discussion: The CAC members discussed the funding recommendations.

Action Taken: Motion to support the 3% increase and the funding recommendations as well as to have a member from the CAC speak on behalf of the whole committee during public comments by Sandra Chamblee. Second by Barbara Jacobowitz. Motion approved and adopted by unanimous vote.

Agenda Item: 3.C. CAC/HHS Membership Matrix (James Green & David Rafaidus)

- David Rafaidus mentioned that the CAC/HHS currently has three (3) membership seats vacant and the vacancies need to be addressed asap.
- James Green added that there are numerous interested parties and the goal is to have the list of those individuals to the CAC/HHS Executive Committee by the June meeting so they can vote.

- James Green gave a brief history on the journey that has led to the topic of economic mobility and how to reduce poverty.
- Mr. Green gave a PowerPoint presentation and discussed the vision and the mission of the poverty initiative.
- Poverty is far-reaching and it affects everyone. It is not just a moral issue but an economic issue as well
- There are three overarching actions intended with this initiative: examining the lake, feeding the fish, and aiming for prosperity.
- Mr. Green went over the anticipated timeline and milestones through the next year.
- Barbara Jacobowitz asked about collaboration with other community entities and Mr. Green informed her that its definitely occurring, specifically through Birth to 22 connections.
- Sharon Greene also noted the importance of having community members or targeted families at the table.
- Various community conversations will be held in various areas around the county.
- Mr. Green added that a report on next steps and a more finalized timeline will be presented to the CAC/HHS soon.
