These funding recommendations are subject to the Board of County Commissioners' approval and successful contract negotiations. Funding recommendations are currently scheduled to be presented to the Board of County Commissioners for approval at their meeting on July 8, 2025. As a reminder, the Cone of Silence remains in place.

"Cone of Silence" means a prohibition on any non-written communication regarding this Notice of Funding Opportunity (NOFO) between any Proposer or Proposer's representative and any County Commissioner or Commissioner's staff. A Proposer's representative shall include. But not be limited to, the Proposer's employee. Officer, director, or consultant, lobbyist, or any actual or potential subcontractor or consultant of the Proposer.
