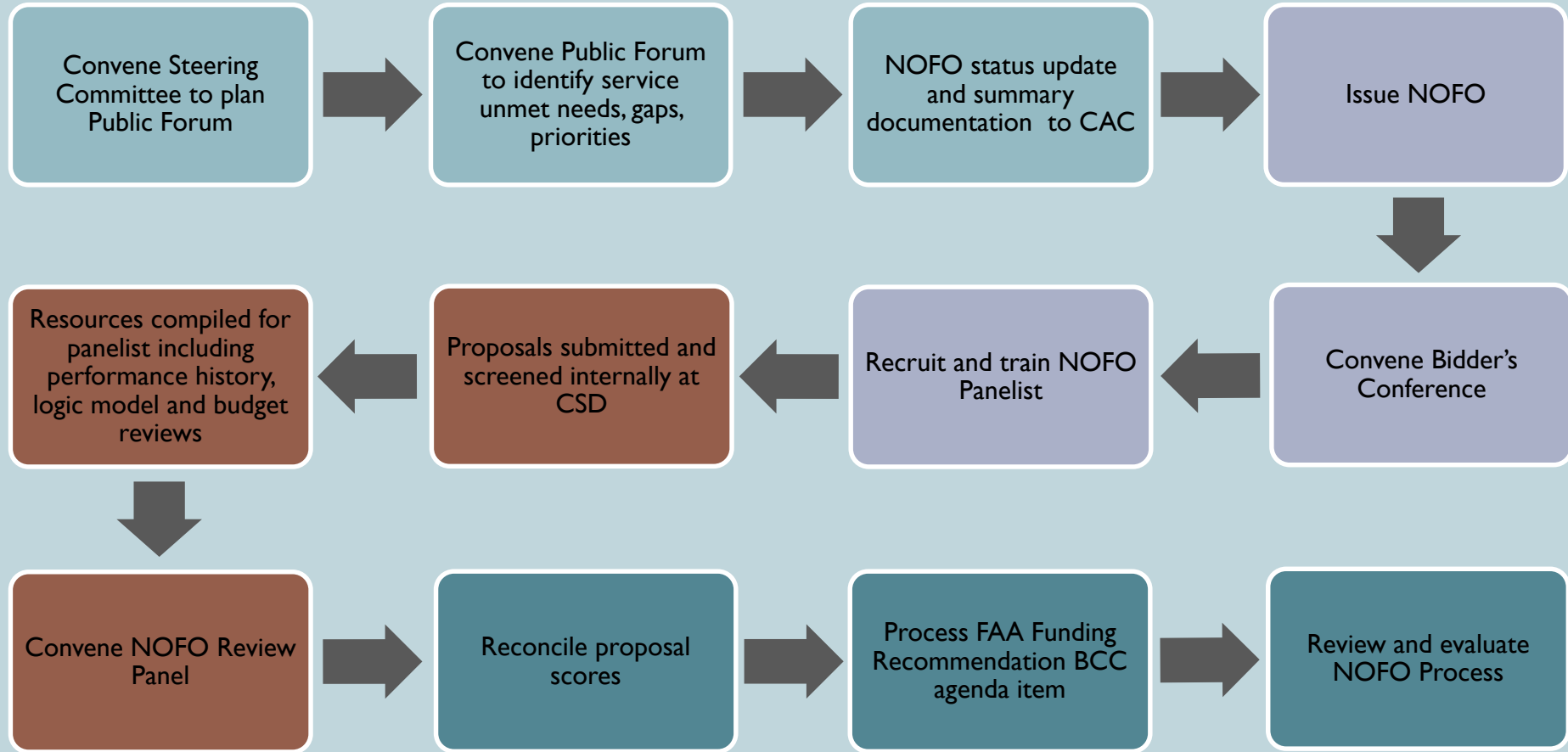
FAA Objectives

CONE OF SILENCE

This NOFO includes a Cone of Silence. The Cone of Silence will apply from the date the NOFO is due, which is April 10, 2025, until the final FAA contracts are approved by the Board of County Commissioners.

Respondents are advised that the "Palm Beach County Lobbyist Registration Ordinance" (Ordinance), a copy of which can be accessed at: http://discover.pbcgov.org/legislativeaffairs/Pages/Lobbying_Regulations.aspx is in effect. The Respondent shall read and familiarize themselves with all of the provisions of said Ordinance, but for convenience, the provisions relating to the Cone of Silence have been summarized here.

"Cone of Silence" means a prohibition on any non-written communication regarding this NOFO between any Respondent or Respondent's representative and any County Commissioner or Commissioner's staff any member of a local governing body or the member's staff, a mayor or chief executive officer that is not a member of a local governing body or the mayor or chief executive officer's staff, or any employee authorized to act on behalf of the commission or local governing body to award a contract. A Respondent's representative shall include but not be limited to the Respondent's employee, partner, officer, director or consultant, lobbyist, or any, actual or potential subcontractor or consultant of the Respondent.

The Cone of Silence is in effect as of the submittal deadline. The provisions of this Ordinance shall not apply to oral communications at any public proceeding, including pre-bid conferences, oral presentations before selection committees, and contract negotiations during any public meeting. The Cone of Silence shall terminate at the time that the BCC awards or approves a contract, rejects all proposals or otherwise takes action, which ends the solicitation process.

SUNSHINE LAW

A NOFO Review Panel is subject to Florida's Sunshine Law because it is engaged in the formal governmental action of sorting through various proposals and scoring and/or ranking them. The NOFO Review Panel is engaged in a governmental decision-making function, in essence doing the work of the Board of County Commissioners.

Review Panels must meet to discuss proposals in the sunshine. This requires:

- Meeting is publicly noticed
- Meeting is recorded – all comments concerning the scoring and/or ranking of proposals must be recorded. Do not discuss any aspect of the proposals when you are “off the record” such as during breaks or in private conversations with another Review Panel member
- Members of the public, including proposers, are afforded an opportunity for public comment, this is not a question and answer period
- Each proposal presented to the Review Panel must be scored by each member of the Panel, and generally Review Panel members will sign one scoresheet per proposal
- The proposals review will be an electronic process and all documents will be saved. Additional documents and notes taken for the scoring must be submitted to Community Services Department after the proposals are scored. These documents are public records subject to disclosure on request

APPLICATION Review Process

- CSD shall recruit FAA Review Panel members.
- Review Committee members shall be trained, as appropriate, and receive submitted applications.
- Applications shall be reviewed, discussed, scored, and ranked by the FAA Review Committee.
- Funding recommendations, based in part by the scoring and ranking, are submitted to the CAC/HHS for comments.
- Funding recommendations are posted to the FAA website
- Applicant(s) have ten (10) business days following posting of funding recommendations to file a grievance notice.
- Contract agreements based on the funding recommendations, are submitted to the BCC for final approval in September 2025.

Priority Area Score

The proposal's SCORE is reflective of how competitive the proposal is.

The Review Panel will rank all proposals based on how critical they deem the program is for the system of care.

The RANKING of the proposals is reflective of how imperative and critical the services are to ensure availability and access.

Ranking Guide and Process

- Please review the ranking guides in the NOFO for each of the categories.
- There is a separate guide for Economic Stability, Self Sufficiency and Intellectual/Developmental Disabilities
- Each application will be scored and ranked.
- The proposals considered the most critical to the system of care will be ranked #1. All proposals will be ranked.
- No two proposals will be ranked the same, as in a tie.
- If there are 10 proposals, then the ranking should ultimately have 10 proposals ranked 1 through 10, with 1 being deemed the most critical.

Continuous Quality Improvement Recommendations

All agencies are required to propose a Continuous Quality Improvement Project.

The project could focus on:

- Enhancing programmatic services/outcomes;
- Improving data management practices

REQUIREMENTS

Client Management Information System (CMIS) All agencies awarded FAA funds must participate in CMIS. All clients served with FAA funds must be entered into CMIS. Funding requires that all clients served be entered and exited in CMIS during the applicable fiscal year. Agencies must execute the required partner and user agreements with Palm Beach County and must participate in the data sharing of CMIS on an ongoing basis throughout the term of their FAA contract in order to maintain eligibility for reimbursement.

Non Profits First Certification-County recognizes the certification process for nonprofit agencies through Nonprofits First: www.nonprofitsfirst.com. Non-Profits First Certification may be exempt for agencies that provide documentation of certification from another funding or oversight body recognized by their industry or if their agency has received two (2) consecutive monitoring reports from FAA with no findings. Exemptions must be requested and approved by the Department of Community Services each contract year. **Requests for exemption must be indicated in the proposal Cover Page- Non Profits First section.** All non-exempted agencies contracting with the County will be required to maintain certification or be certified within 18 months of their initial contract date.

Properly complete, sign, and return conflict of interest.

Do Not Discuss your Proposals with other Review Panel and/or CAC Members

Reviewing Proposals

- ✧ Highlight/note language that aligns with criteria in the proposal guidance.
- ✧ Review budget, attachments, and other supporting documentation.
- ✧ Evaluate proposals independently on its own merit against the evaluation criteria only.
- ✧ Please review all assigned proposals prior to the review panel and complete the Comment Form.
- ✧ The Comment Form will be part of the Public Record.
- ✧ Please do not score proposal until after the panel discussion meeting.
- ✧ Applications must be considered in a manner that is:
 - Complete
 - Fair
 - Objective
- ✧ Review Comment Writing Guide.

Evaluative Feedback

Use “evaluative” feedback in the discussion.

Evaluative feedback during the panel discussion that provides value, worth, or quality of the information in the application.

Evaluative feedback is important.

- ✧ This assists staff in the funding process.
- ✧ It serves as technical assistance to applicants – future proposals.
- ✧ Recordings of this meeting will be online for applicants to listen to and they will use information that you provide when developing future proposals.

Participation

- ✧ Reviewer etiquette should be respectful, sensitive and tactful.
- ✧ Contribute to review discussions of each proposal's strengths and weaknesses.
- ✧ Be ready to discuss each proposal fully.
- ✧ Be mindful of the time allocated for the discussion.
- ✧ Try not to over-discuss a proposal to the detriment of the other proposals.
- ✧ Each reviewer is required to stay for the whole panel review meeting.



IV. Proposal Review Process – Michael Wright, Contract Manager

Review Process Summary

- Proposal eligibility requirements are reviewed internally by Department staff.
- Eligible proposals are assigned to Reviewers in SAMIS.
- Proposals are reviewed by the panelists.
- Brief presentation by Fiscal Staff and Evaluation Staff.
- Panels convene and score proposals.
- Once all proposals are scored, the proposals are ranked.
- The recording of the Panel reviews are posted online for several years.

Eligibility Requirements

All proposals were reviewed for the following Eligibility Requirements prior to making them accessible to you.

The Eligibility Requirements include:

- The proposal was submitted in SAMIS no later than April 10th at 12:00 p.m.
- Applicants are a registered Florida non-profit entity, verified in Sunbiz, provided services for 6 months.
- Proposed/recommended award cannot exceed 25% of Agency's total budget

Reviewing Budgets - Tips

- Proposed budget items should be detailed.
- ✓ Don't - "3 employees.....\$75,000"
- ✓ Do - Specific positions and roles, what they do for the program, and how funds are allocated to pay for each

- ✓ Don't - "supplies" or "consultants"
- ✓ Do – detailed list of supplies and what they will be used for

- Other funding sources should be listed
- ✓ Confirmed or pending,- how much of the program is funding requested for?
- ✓ Weight should be given to programs with other community resources being used. If FAA is the only funder should be examined more closely. Being the only funder is not necessarily something to deduct points for but it should be examined and questioned

Reviewing Budgets - Tips

- Some agencies may put the 3 years total in the budget instead of 1 year. This is fine, it just should be considered in discussions to ensure consistency.

Comment Form Guide Review

- Use it to take notes
- As a tool for discussion during panel
- To remember criteria for scoring

Score Sheet Review

- Department staff will guide the review process, and will try to keep review of proposals to 20 minutes each.
- Please come prepared with your questions/comments.
- All notes and score sheets will be turned in and are subject to public record requests.

Ranking Guide

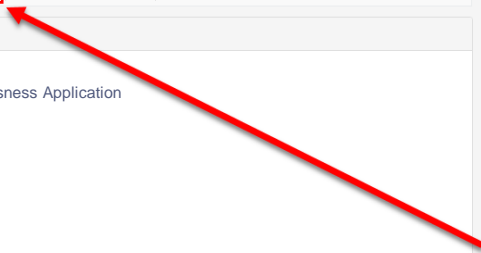

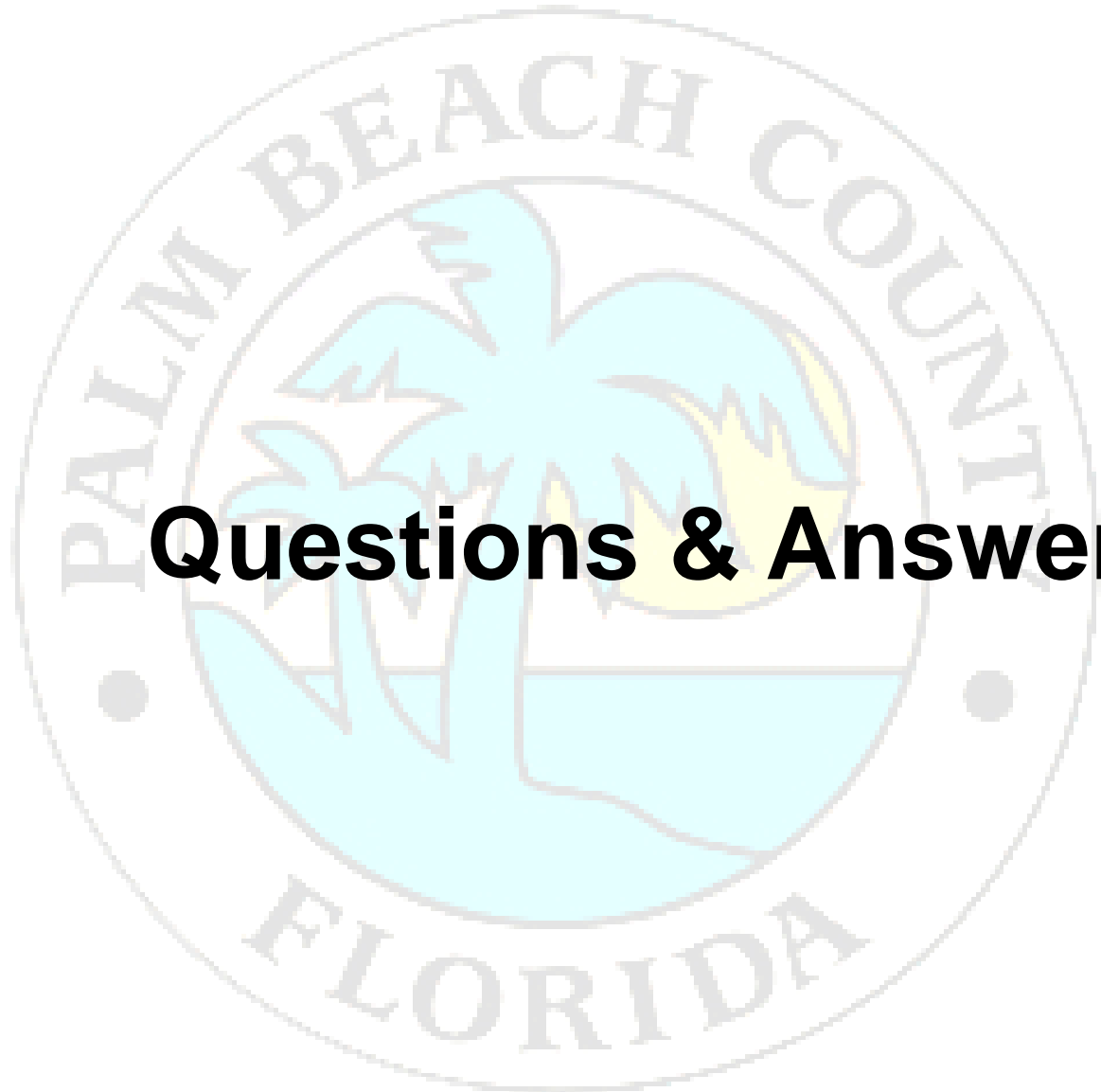
