Basic Criteria

Allowable Activities

- PERMANENT SUPPORTIVE
 - HOUSING
- RAPID REHOUSING
- JOINT TRANSITIONAL HOUSING / RAPID REHOUSING
- SUPPORTIVE SERVICES

People Served

Must be Literally Homeless (HUD Category 1)

- Living in a place not meant for human habitation
- Living in a temporary shelter
- Exiting an institution (hospital, jail, etc.) where they have resided for 90 days or less and resided in a place not meant for human habitation immediately before entering the institution -OR-

Meet HUD Category 4

Fleeing or attempting to flee domestic violence, dating violence, sexual assault stalking or other dangerous or lifethreatening conditions that relate to violence against an individual or family member

HUD Priority: Individuals and Families **Experiencing Homelessness with** Severe Service Needs

Any Combination of the Following:

- People with disability(ies) who require a significant level of support to maintain permanent housing
- High utilization of crisis or emergency services to meet basic needs
- Currently living in an unsheltered situation or have a history of doing so
- Experiencing vulnerability to illness or death
- Having a risk of continued or repeated homelessness
- Having a vulnerability to victimization

More Priorities:

- Identify people living in unsheltered situations including encampments and connect them with health and housing resources
- Enhance Client Mangagement Information System to collect more comprehensive data
- Involve an broad array of stakeholders in the effort to reduce homelessness, including people with lived experience or people experiencing unsheltered homelessness
- Advance Equity
- Must use a Housing First Approach

Committee; selected applications submitted to HUD as part of the HHA Consolidated Application.

Applicant must meet all threshold criteria for the application to move forward.
