- I. Welcome and Opening Comments – Chairman Martz
- II. Introductions were made.
- III. The agenda and minutes were approved by a motion from Seth Bernstein and seconded by Megan Eaton.
- IV. Business:
  - a. Kristina Henson mentioned a couple changes to align with the PBSO grant. These include changing the name to Palm Beach County School & Community Safety Initiative Behavioral Health Track and adding new members (Nicole Bishop, PBC Director of Justice & Victim Services, William Wims, South County Mental Health Director of Acute Care, and Sara Talley, FBI Special Agent) to the committee.
  - b. Stephen Plunk discussed the different options for the slogans. He noted that the slogan in option three uses the current lingo. It is also the most direct and it rhymes. Kristina Henson mentioned that the group previously approved “Be Aware and Care”, but that slogan may be confused with the BeWell campaign. The group approved the logo and slogan in option three. Kristina Henson will work on purchasing the domains.
  - c. Kristina Henson reviewed the proposed website layout. She thanked Danielle Ouellette and Katherine Shover for preparing the provider list. The website sub-committee was also recognized for their hard work. Chairman Martz suggested that 211 and the other hotlines be listed first on the site. The committee also requested a banner at the top of the page for emergency numbers. Sara Talley will check to see if the FBI has a hotline number to call in threats. Craig Williams, Sara Talley, and Lt. Foley will work on the header language. It was noted that 211 answers several of the hotlines including the ones for suicide, disaster distress, and victim services. There was a discussion about determining which providers will be listed on the site. Sharon L’Herrou mentioned that 211 has an extensive process to vet providers. They also have the ability to search by topic and filter searches. The group discussed the possibility of using the list prepared by 211. Jill Sorenson mentioned leveraging the resource of 211 and that it would be easier to use one site. Chairman Martz noted that he would like the Aware and Care site to be like trip advisor and to have a quick google search capability.
  - d. June Eassa mentioned that the school website will be released soon. A committee developed criteria and an application for providers interested in being listed. She
