  - A. The 3<sup>rd</sup> Palm Beach County Re-Entry Transition Fair was held on Friday, May 14, 2010 from 10:00 a.m. to 1:00 p.m. at the Old School Square, 51 N. Swinton Avenue, Delray Beach. The event was hosted by County Commissioner Priscilla A. Taylor and the Palm Beach County Criminal Justice Commission’s Weed and Seed program, and assisted persons who have been incarcerated to re-enter society as productive citizens. Local service providers from throughout the County were in attendance.
  - B. The Executive Committee of the Criminal Justice Commission approved staff recommendation for grant submission to OJJDP for a Youth Gang Prevention and Intervention Program. The grant is for \$325,000.00 and is being targeted to enhance the five (5) Youth Empowerment Centers which are designed to reduce violent crime.

The Executive Committee of the Criminal Justice Commission recommends approval of the purchase of a Forensic Buddy to aid the Riviera Beach Police Department (RBPd) in the amount of \$3,000.00 from the FDLE YVPP grant funding, subject to information outlining the benefits to be derived from this purchase, the program initiative, the status of BrassTrax, the number of equipment in the County and amount needed including other details. This would significantly increase the number of guns test fired by RBPd for BrassTrax entry benefiting the attainment of our collective goal to link violent crimes involving firearms.
