# A. Jail Population Report

Major Kneisley reported that the total population of the jail remains lower than the jails' capacity.



# **B.** Jail Counselor Report

The Jail Counselor, Mr. Fondiller, provided a report that showed the status of DCF transfers and misdemeanor booking averages. Mr. Fondiller reported that the total average of days misdemeanants spent in jail in August was 3.03 days. He added that the average number of days for misdemeanants between booking and sentencing was 4.17 days. Mr. Fondiller reported that no inmates were waiting to be transferred to the state hospitals and four inmates were transferred to the state hospitals in August. He also reported that no inmates were waiting to be returned from DCF and two inmates were returned from DCF in August.

## C. **Juvenile Detention**

Department of Juvenile Justice Superintendent, Anthony Flowers supplied a report that showed the average population of the juvenile detention center from May through August. He reported that the current average population is at 34 which is the lowest population level he has experienced in his entire career.

## D. Pretrial Services Report

The Pretrial Services Manager, Mr. Trotta, provided members with a printed report detailing the Supervised Release Pretrial Services Program. The report notes that it is current as of August 31st. The report showed that there are a total of 1,069 defendants on Supervised Own Recognizance (S.O.R.) and that 948 of these are out of custody. Fifteen individuals were on S.O.R. and were in custody for the following reasons:

Probation/Parole Violation 1
S.O.R. to Treatment 5
Bonds or No Bonds on Other Charges/Holds 9

# V. Updates

## **A.** Bookings by Statute required by FDLE:

Captain Starks provided the Task Force with an update regarding the discrepancies in the booking statute requirements by the Florida Department of Law Enforcement. Captain Starks discussed Inmate booking and the FDLE charging tables. FDLE is now requiring arrest data to be transmitted electronically and it must be very accurate. Booking charges must now come from the FDLE charging tables. Not all agencies are using the FDLE tables which is problematic. Capt. Starks stated that the State Attorney's office (SAO) has been working with the Sheriff's office diligently to identify and mitigate the discrepancies. Ms. Richstone (SAO) mentioned that this is a problem that has occurred for many years. This statewide issue is being addressed in a separate subcommittee chaired by the State Attorney's Office. Chief Crane added that the Law Enforcement Planning Council is also discussing this issue as it relates to police agency information management systems.

# **B.** Legislation Relating to Department of Corrections, CS/SB 1722:

Ms. Link provided the Task Force with a copy of a new bill that could have an impact on the county jail. She noted that, in part, the bill relates to third degree felonies and allows judges discretion on sentencing certain offenders under the legislative change. Ms. Baker added that she will provide a copy of the Department of Corrections' informational outline of the legislations' meaning.

#### VI. New Business

Impact of the elimination of the Drug Farm and SAAP program:

Ms. Link presented an impact analysis report on the possibility of the SAAP program elimination for fiscal year 2010. She provided a background on the program with data on the usage of the services. She also provided positive information on the compliance, accreditation and success rates for the program. In her report, she noted that a comparison of the recidivism rates for the SAAP is at 31% while the general population of the jail is at 51%.

Ms. Link presented a breakdown of the annual costs associated to the program. She also provided the members with a description of five scenarios depicting the range of impacts to the jail population. Ms. Link then described the scenarios in reference to estimated and current costs. She explained how much the jail population would rise for each scenario. In conclusion, she stated that while eliminating the SAAP would result in an immediate cost saving of \$2.6 million, there is a real potential of greater costs in the future related to increased recidivism and jail overcrowding.

Ms. White suggested that the Task Force explore alternative ways of funding the Drug Farm in the upcoming years. Mr. Bozzone agreed that there might be alternate ways of funding the community based program aspects of SAAP due to the importance of the program. He suggested that this could result in a cost savings if it was not operated under the Sheriff.

Ms. Richstone commented that part of the Drug Farm's success is because it is operated by law enforcement. Chief Crane stated that what is in place works well and that this Task Force does not need to reinvent a new program when we have one in the county that is operating so well.

Members discussed and voted unanimously to send a letter, including the impact analysis report as an attachment, on behalf of the Task Force to the Sheriff and to the Board of County Commissioners in support of SAAP. (A letter of support on behalf of the Task Force was sent to the Sheriff and to the Palm Beach County Board of County Commissioners recommending that the County keep SAAP operational on September 4<sup>th</sup>).

#### VII. Old Business

**A.** Changes on Misdemeanor FTA bonds per F.S. 903.046:

Barbara White of the Public Defender's office supplied members with a draft change to the Florida Statute in reference to the bonds set for failure to

change to the Florida Statute in reference to the bonds set for failure to appear cases for the Task Force's review and discussion at the next monthly meeting.

**B.** Comparison of other counties percentage in jail on no bond:

Major Kneisley of the Palm Beach Sheriff's Office provided comparative information from other counties in Florida on inmates that are in custody with no bond. He commented that Palm Beach County averages 51% of jail inmates are held without a bond and noted that Hillsborough County averages 67% and Jacksonville averages 42% for the same category.

## VIII. Additional member and guest comments

Judge Colbath stated that his courtroom was chosen as a pilot project site for video conferencing on judicial proceedings for defendants. He discussed the new pilot program and is examining possible ways to reduce the number of felony inmates needing transportation for hearings from Gun Club to the main Courthouse. They will be seeking to provide opportunities for defendants to have confidential communications with their attorney and to participate in a hearing. The technology is expected to be installed by the end of October. Chairman Duncan informed members that the next meeting is scheduled for October 7<sup>th</sup> at noon.
