Glossary of Terms

Offenses: Crimes (attempted or committed) reported to law enforcement agencies. Collected for Part I crimes only.

Index Crime: Seven major crime classifications of the most serious offenses selected to serve as a gauge in measuring fluctuations in the overall volume and rate of crime. Further categorized as Index Violent Crimes and Index Non-Violent Crimes.

Index Violent Crimes: Crimes against persons including murder, rape, robbery, and aggravated assault.

Index Non-Violent/Property Crimes: Crimes against property including burglary, larceny, and motor vehicle theft.

Index Rate: Total index crimes per 100,000 population.

Arrests: Arrests of persons made by law enforcement agencies, including notice to appear. Collected for Part I and Part II crimes.

Arrest Rate: Total number of arrests per 100,000 population.

Part I Crimes: Major crime classifications including murder, rape, robbery, aggravated assault, burglary, larceny, and motor vehicle theft.

Part II Crimes: Crime classifications not already designated in Part I crimes including manslaughter, kidnapping/ abduction, arson, simple assault, drug arrest, bribery, embezzlement, fraud, counterfeit/forgery, extortion/ blackmail, intimidation, prostitution, non-forcible sex, stolen property, dui, destruction/vandalism, gambling, weapons violations, liquor law violations, and miscellaneous (combined category for prostitution & commercial vice, offenses against family & child, vagrancy, suspicion, curfew & loitering, and runaway).

Defendants Filed: Number of defendants against whom a sworn complaint, notice to appear, information, or indictment is filed before the circuit and county courts.

Defendants Disposed: Number defendants for whom a final judicial decision is rendered terminating a criminal proceeding by an acquittal, a dismissal, or a judgment stating the specific sentence (in the case of a conviction).

Average Daily Population: Annual ADP is obtained by adding the average monthly ADPs for the current year, divided by 12 months. Monthly ADP is calculated by adding the total daily population for the month, divided by the total number days in the current month.

Incarceration Rate: Incarceration Rate per thousand population is calculated by dividing the annual ADP by the county population for current year, multiplied by 1,000.

Key Points

The Palm Beach County Total Index Crime rate has been declining since 2007

- Index crime rate declined by 24.4% since 2008; and declined by 3.1% from 2012 to 2013
- Non-violent rate declined by 23.4% since 2008; and declined by 2.7% from 2012 to 2013
- Violent rate declined by 30.8% since 2008; and declined by 5.9% from 2012 to 2013
- Rates for murder decreased by .8% from 2012 to 2013
- Forcible sex offense rates decreased by 8.6% from 2012 to 2013

Palm Beach County Arrests have been declining since 2008

- Total arrests declined by 30.8% from high in 2008 to 2013; and declined by 1.8% from 2012 to 2013
- Juvenile arrests declined by 37.2% from high in 2008 to 2013; and declined by .5% from 2012 to 2013

Slight increase in Palm Beach County law enforcement rate from prior year

- Rate increased by 3.7% from 2012 to 2013
- Highest rate was 2.70 in 2009 during 1997-2013 period

Key Points

There was a generally upward trend in Average Daily Jail Population (ADP) from 1995 to its peak in 2008; and a downward trend from 2008 to 2014.

- There was a 44% increase in ADP from 1995 to 2008; and a 26% decrease from 2008 to 2013.
- Since 2009, actual ADP has been lower than projected ADPs from two studies.
- PBC has the lowest ADP and Incarceration Rate among 7 comparable counties from 2010 to 2013.

Admissions to DOC from PBC had a generally upward trend from FY96-97 to FY10-11, then declined; Releases to PBC from DOC also had an upward trend from FY96-97 until FY11-12, then declined.

- There were more admissions than releases from FY05-06 until FY11-12; releases exceeded admissions in the last two fiscal years of FY12-13 and FY13-14.

Misdemeanor probation population has had a generally steady decline since 2002.

- The number of offenders under misdemeanor probation and pretrial intervention has decreased by 34% from 2002 to 2014.

The average inmate cost per day has fluctuated since FY95-96, peaking during FY07-08.

- Since FY 95-96, there has been an 11% increase in the housing cost per inmate.
- There was a 4% increase in the cost of corrections during the last year.

Key Points

Generally, there was an upward trend in Total Criminal Court Filings from 1995 to its peak in 2008; and a downward trend from 2008 to 2013.

- There was a 32% increase in Total Criminal Court Filings from 1995 to 2008; and a 39% decrease from 2008 to 2013.
- PBC has the 3rd highest Total Criminal Court Filings among 7 comparable counties from 2010 to 2013; behind Broward and Miami Dade.

The total number of criminal court judges has virtually remained unchanged from 2003 to 2013.

- Overall, the total number of Judges for PBC increased by .55 from 2003 to 2013 from 18.40 to 18.95.
- Among 7 comparable counties, the total number of criminal court judges was the lowest for PBC between 2010 and 2013.


Overall, the total number of youth referred to DJJ has been steadily declining since FY 09-10.

- The total number of youth referred to DJJ has declined 38% since FY 09-10.
- The total number of minority youth referred to DJJ has declined 34% since FY 09-10.
- The total number of youth referred to DJJ has declined 11% in the past year.
- The total number of minority youth referred to DJJ has declined 8% in the past year.

The number of youth direct filed in Palm Beach County increased between FY12-13 and FY13-14


- The number of youth direct filed in Palm Beach County increased 22% between FY12-13 and FY13-14

Population for Palm Beach County and Comparable Counties, 2013





Index Crime Offenses in Palm Beach County, 1995-2013





Index Offense Rate in Palm Beach County, 1995-2013





Violent Crime Rate per 100,000 Comparison, 2009-2013 Average






Comparison of Domestic Violence Offense Rates in Palm Beach County and Florida, 1996-2013




Firearm Use in Murder and Violent Crime Offenses in Palm Beach County, 1996-2013






Arrest Rate in Palm Beach County, 1998-2013




Palm Beach County Juvenile Arrest (Part I & II) Trends, 1998-2013



Part I Offenses Cleared By Arrest or Exceptional Means in Palm Beach County and Florida, 1998-2013







Palm Beach County Youth Referred to the Department of Juvenile Justice, 2009-2014





Number of Youth Direct Filed in Palm Beach County, 2009-2014





Rate of Youth Direct Filed, Palm Beach County Compared with Other Counties, 2009-2014






Circuit and County Criminal Court Filings, Palm Beach County, 1995-2013

Circuit and County Criminal Court Dispositions, Palm Beach County, 1995-2013




Total Criminal Court Filings and Dispositions, Palm Beach County, 1995-2013

◆ Total Filings ▲ Total Dispositions






Circuit Criminal Court Dispositions After Trial, by Type, Palm Beach County, 1995-2013


County Criminal Court Dispositions Before Trial by Type, Palm Beach County, 1995-2013



County Criminal Court Dispositions After Trial by Type, Palm Beach County, 1995-2013





Clearance Rate for Total Criminal Court Filings, Palm Beach County, 1995-2013






Total Criminal Court Dispositions, Palm Beach and Comparable Counties, 2010-2013

■ 2010 ■ 2011 ■ 2012 ■ 2013






Average Daily Population, Palm Beach County Jails, 1995-2014


Incarceration Rate, Palm Beach County Jails, 1995-2014

Average Daily Jail Population, Palm Beach and Comparable Counties, 2010-2013




Incarceration Rate for Palm Beach County, Comparable Counties and Florida, 2010-2013



Admissions & Releases for Palm Beach County, Florida Department of Corrections FY96-97 to FY13-14





Misdemeanor Probation Population, Palm Beach County, 2002-2014









Palm Beach County Juvenile Detention Center, 2005-2013






Law Enforcement Officers in Palm Beach County, 1997-2013


Rate of Law Enforcement Officers in Palm Beach County, 1997-2013



Rate of Law Enforcement Officers in Palm Beach County, Comparable Counties and Florida, 2010-2013






Rate of Sheriff Officers in Palm Beach County, Comparable Counties and Florida, 2010-2013


Number of Judges, Palm Beach County Criminal Courts, 2003-2013

■ Circuit ▲ County × TOTAL





Number of Total Criminal Judges, Palm Beach and Comparable Counties, 2010-2013





Number of Circuit Criminal Judges, Palm Beach and Comparable Counties, 2010-2013






Florida Department of Corrections Total Expenditures (Per Fiscal Year), 1995-2014


