FIVE YEAR ROAD PROGRAM

Public Hearing (December 7, 2021)

THE FIVE YEAR ROAD PROGRAM WAS ESTABLISHED BY ORDINANCE 85-40 TO SET FORTH THE ROAD PROJECTS TO BE FUNDED, DESIGNED AND CONSTRUCTED BY THE COUNTY WITHIN THE NEXT FIVE YEARS.

FUNDING SOURCES INCLUDE:

•IMPACT FEES •PROPORTIONATE SHARE •GAS TAXES •INFRASTRUCTURE SALES TAX •FDOT AGREEMENTS AND MISCELLANEOUS AGREEMENTS (SEE EXHIBIT A, PAGE 1 OF 5)

The Five Year Road Program <u>Annual Update</u> includes adjustments to projects funding for Fiscal Years 2022 through 2026.





Study Highlight – Northlake Blvd

- Produce preliminary layout for 142' ROW, 11' widening on both sides and investigate possibility of additional 11' of widening to replace existing right turn lanes
- Produce preliminary plans for new through lanes at intersections
- Provide preliminary drainage calculations to estimate capacity needs for widening
- Estimate ROW acquisition costs
- Estimate construction costs for widening from 6 to 8-lanes

- November December 2021: Negotiate
 Consultant Scope and Fee
- March 2022: Award consultant study contract and begin study
- August 2022: Submittal of Draft Study for PBC Staff Review & Comment
- October 2022: Final Study Submittal

ENGINEERING & PUBLIC WORKS INFRASTRUCTURE UPDATE

- 3,500 lane miles of paved roads
- 40 miles of shell rock roads
- 10 miles of asphalt milling roads
- 1,130 miles of concrete sidewalks
- 190 miles of asphalt pathways
- 2,500 acres of right of way to mow
- 8 bascule bridges, 1 swing bridge
- Maintain over 10,700 beautification trees
- Maintain over 44 miles of beautified
- median landscaping on state highways









- 1,250 traffic control signal devices with over70 coordinated signal systems
- 850 signals with real-time monitoring
- 180 CCTV installations
- 470 miles of fiber optic communications for Intelligent Transportation System (ITS) network

Flashing Yellow Arrow for Left Turn

- First deployed November 2019
- Already installed at 15 intersections and 40 more are in the process
- Improves pedestrian safety
- Reduces signal delay

Engineering & Public Works Department

- Adopted as a County design standard for all <u>new</u> signals
- <u>Existing</u> signals will be converted based on safety needs
- Traffic Division developing project proposals to secure federal safety funding for massive conversion of existing signals (over 900)

Traffic Signal Infrastructure Improvements

Safety Initiatives

- Transit Signal Priority (TSP) system deployment on US Hwy 1 and Okeechobee Blvd Corridors in FY-23 and FY-24 in cooperation with Palm Tran through a grant from Palm Beach TPA
- Emergency Vehicle Preemption (EVP) system in cooperation with PBC Fire Rescue. Deployment on several major corridors following the TSP deployment
- Installing reflective back plates to improve signal display visibility on all new signals
- Upgrading 27 signals from span wire to mast arm through FDOT
- Deployed cellular communication system at 90 school flashers



Pedestrian Safety Improvement Updates

Flashing Pedestrian Crosswalks

- Received a Transportation Alternative Program grant through Palm Beach Transportation Planning Administration
- 24 existing crosswalk locations on Ocean Dr. and A1A (between Donald Ross Rd. and Indiantown Rd.)

Pedestrian Signals

- Deployed affirmative (audible/visual confirmation) pedestrian pushbuttons. More than 200 intersections have been fully retrofitted to date
- Deployed countdown pedestrian signals. More than 75% of all signals have been converted to date



Sidewalk Program

- \$1.5M in annual capital funding.
- Focuses on providing a system of safe pedestrian sidewalks within the County, especially safe access to Schools and other community resources.

Bike Lane Updates

- Lyons Road / Sansbury's Way (Forest Hill Boulevard to Okeechobee Blvd.) – Separated Bike Lanes
 - \$5M
 - Approximately 2.8 miles
 - Scheduled for construction FY 2023
- Cresthaven Boulevard (Jog Road to Military Trail) Buffered Bike Lanes
 - \$4.6M
 - Approximately 2.1 miles
 - Scheduled for construction FY 2024
- Prosperity Farms Road (Northlake Boulevard to Donald Ross Road) – Standard Bike Lanes
 - \$13M
 - Approximately 5 miles
 - Scheduled for construction FY 2026
- PBC has added or refurbished 311,608 linear feet of bike lanes since 2017.







Railroad Safety

DYNAMIC ENVELOPE PAVEMENT MARKINGS

- We are in the process of applying for a permits to add the new "Dynamic Envelope Pavement Markings" at certain existing crossings with FEC, SCFE and USSC railroads. These are enhanced pavement markings to warn the public of the railroad crossing.
- SFRTA railroad have been adding these marking to their crossings.
- FEC is adding them to the crossings they are working on in north County.
- The FDOT has a federal grant (CRISI) that will add them to several crossings out in the Glades area and several along CSX. The FDOT project along the Beeline will be adding them to impacted railroad crossings as well.
- The County is planning on adding the Dynamic Envelope Markings at 15 crossings: 11 are on FEC Railroad Crossings, 3 at SCFE Railroad Crossings and 1 at an USSC Railroad Crossing (the SCFE & USSC are in the Glades region).

2023 - 2045 NEW ROADS AND WIDENING OF EXISTING ROAD LINKS




2045 – AND BEYOND NEW ROADS, INTERSECTIONS, AND WIDENING OF EXISTING ROAD LINKS

Estimated to be over \$1 Billion








