This Amendment No. 2 to the Annual Small Paving and Minor Construction Contract (R2019-1833) dated December 3, 2019 (ANNUAL CONTRACT) is made and entered into the \_\_\_ day of ~~NOV 02 2021~~ 2021, by and between Palm Beach County, a political subdivision of the State of Florida, by and through its Board of County Commissioners (COUNTY), and R & D Paving, LLC (CONTRACTOR) whose Federal ID is 45-4469049 (individually Party and collectively Parties).

**WITNESSETH**

WHEREAS, the COUNTY and CONTRACTOR entered into the ANNUAL CONTRACT on December 3, 2019 (R2019-1833), as amended on November 17, 2020 (R2020-1631); and

WHEREAS, the ANNUAL CONTRACT may be extended, at the COUNTY'S option for a defined period of time, not to exceed thirty-six months total contract time, upon approval of the COUNTY; and

WHEREAS, by this Amendment No. 2, the CONTRACTOR and the COUNTY mutually agree to amend the ANNUAL CONTRACT, as provided herein.

NOW, THEREFORE, in consideration of the mutual covenants, promises, and agreements herein contained, the Parties agree as follows:

1. The above recitations are true and correct and incorporated herein
2. The ANNUAL CONTRACT is hereby amended to extend the expiration date from December 2, 2021 to December 2, 2022.
3. The ANNUAL CONTRACT is hereby amended to increase the amount by \$100,000, from \$3,000,000 to \$3,100,000.

It is the intent of the Parties hereto that this Amendment No. 2 shall not become binding until the date executed by the COUNTY.

Except as hereby amended, changed or modified, all other provisions of the ANNUAL CONTRACT as amended, shall remain in full force and effect.

IN WITNESS WHEREOF, the Board of County Commissioners of Palm Beach County, Florida has made and executed this Amendment No. 2 to the ANNUAL CONTRACT on behalf of the COUNTY, and CONTRACTOR has hereunto set its hand the day and year above written.

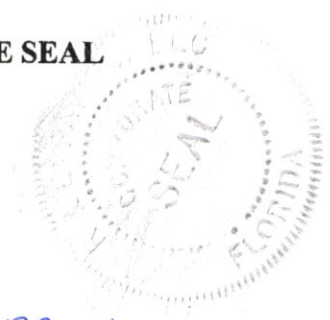
