

**AMENDMENT NO. 1 TO THE
ANNUAL TRAFFIC SIGNAL CONSTRUCTION CONTRACT
BY AND BETWEEN PALM BEACH COUNTY
AND GERELCO TRAFFIC CONTROLS, INC.**

This Amendment No. 1 to the Annual Traffic Signal Construction Contract (R2019-1260), dated September 10, 2019, (ANNUAL CONTRACT), is made and entered into the ____ day of JUL 07 2020, 2020, by and between Palm Beach County, a political subdivision of the State of Florida, by and through its Board of County Commissioners (COUNTY) and Gerelco Traffic Controls, Inc. (CONTRACTOR) whose Federal ID is #90-0174266 (individually Party and collectively Parties).

W I T N E S S E T H

WHEREAS, the CONTRACTOR and COUNTY entered into the ANNUAL CONTRACT on September 10, 2019 (R2019-1260); and

WHEREAS, the ANNUAL CONTRACT may be extended, at the COUNTY'S option for a defined period of time, not to exceed thirty-six months total contract time, upon approval of the COUNTY; and

WHEREAS, by this Amendment No. 1, the CONTRACTOR and the COUNTY mutually agree to amend the ANNUAL CONTRACT, as provided herein.

NOW, THEREFORE, in consideration of the mutual covenants, promises, and agreements herein contained, the Parties agree as follows:

1. The above recitations are true and correct and incorporated herein.
2. The ANNUAL CONTRACT is hereby amended to extend the expiration date of the ANNUAL CONTRACT from September 9, 2020 to September 9, 2022.
3. The ANNUAL CONTRACT is hereby amended to increase the amount by \$6,000,000, from \$3,000,000 to \$9,000,000.

It is the intent of the Parties hereto that this Amendment No. 1 shall not become binding until the date executed by the COUNTY.

Except as hereby amended, changed or modified, all other provisions of the ANNUAL CONTRACT, as amended, shall remain in full force and effect.

IN WITNESS WHEREOF, Board of County Commissioners of Palm Beach County, Florida has made and executed this Amendment No. 1 to the ANNUAL CONTRACT, as amended, on behalf of the COUNTY, and CONTRACTOR has hereunto set its hand the day and year above written.
