Dear Property Owners, Neighbors and Interested Parties,

We last communicated with you via letter sent in April 2024, sharing that County staff was proceeding with development of Cam D. Milani Park as per the Town of Highland Beach (Town) approved site plan, development order and Stipulated Settlement Agreement and Addendum (SSAA) applicable to the development project. At the time, we also shared that notwithstanding the constraints imposed by aforementioned documents, our commitment to work with the surrounding community remained intact.

In September 2024, the County retained architectural/engineering professional services from Brooks + Scarpa Architects, Inc. (Brooks). The design efforts have been progressing as planned and we have now reached the point where County staff and its consultants are ready to share conceptual designs with the community.

To that end, and on behalf of Palm Beach County and its Board of County Commissioners, the County's Facilities Development & Operations (FDO) and Parks & Recreation (P&R) departments will be providing a **public presentation** of the project status and the proposed design concepts for the Cam D. Milani Park at the **Palm Beach County South County Civic Center, 16700 S Jog Rd, Delray Beach at 6:00 p.m. on Wednesday, April 2, 2025.** We look forward to receiving public comment and input on this future vision for the park, and will consider the same under the development constraints resulting from the Town approved site plan, development order and SSAA.

We hope you will attend this public presentation should you take interest in the park and/or planning for its public service future.
