Palm Beach County Cam D. Milani Park

Design Imagery, Produce Fabrication Files, Mock-Ups, Fabrication & Installation Coordination for Accoya Boardwalk Railing Panels and Seat Tops

LOCATION: 4705 South Ocean Boulevard, Highland Beach, Florida

BUDGET: \$57,550

DEADLINE: February 6, 2026, by 11:59pm EDT- This is a fast-track project.

A. Project Summary

Palm Beach County's Art in Public Places program (PBC AiPP) seeks to commission an Artist or Artist team (Artist) to design art imagery and coordinate with the project team for the imagery to be integrated into the Accoya wood boardwalk railing panels and seat tops at the proposed Cam D. Milani Park (Park). The Construction Manager will be responsible for translating the Artist's approved imagery into final, fabrication-ready components, including all processes required to laser etch, cut, route, mill, carve, inlay, laminate, or otherwise integrate the imagery into the Accoya wood elements.

Art imagery will be inspired by the local coastal ecology, in addition to the historical and cultural heritage of the site. Artist scope includes design development, producing digital fabrication files, producing full size mock-up of one boardwalk railing panel and one seat top, fabrication and installation reviews and oversight, responding to architect's RFIs, and providing professional digital photographs of the final art installation. The project's Construction Management firm is responsible for fabricating and installing Accoya boardwalk railing panels and seat tops.

The Park's name acknowledges the property's owner at time of purchase by Palm Beach County. The site has a rich and varied history. More than 1,000 years ago indigenous Native American burial grounds were established on the property. In the early 1900's Japanese immigrant farmers and their families, commonly referred to as Yamato Colony, settled in the area. A coral outcropping along the beach's shore was called Yamato Rock as it was a hub for social gatherings, fishing, picnics, and celebrations. This beach was an oasis and primary recreational space for the Yamato community gathering whose heyday was in the 1920s. Today, the beachfront property is known for its natural beauty, near-shore fishing, and a special community place.

Boardwalk and seating images that follow are conceptual and illustrative only of the proposed park improvements.










B. Art Design Goals

- Art imagery will be inspired by the site's coastal ecology, in addition to the historic and cultural heritage.
- Art will be inspired by native south Florida flora and fauna likely to be found at this beach access park, as well as the significance of connection to the previous uses of the site by the Yamato Colony and Native Americans
- Art imagery will foster Park visitors to connect more deeply to the site's past and present-day significance.
- Art will prompt Park visitors to pause and engage more deeply with their surroundings.
- Art will support Parks and Recreation Department efforts to create a welcoming yet safe and environmentally
 protected space for all individuals and groups that use the proposed public park.
- Art will provide visual interest that invites new discoveries for contemplation in the Park, away from beachfront.
- Art will complement the Park's architectural style, boardwalk and seating materials and scale.
- Art design and materials will meet Florida Building Code and International Building Code requirements.
- Art design and materials will not conflict with sea turtle lighting ordinance.
- Art design will be safe, durable and require minimal maintenance. Art materials must withstand the intense local environment (sun, high winds, salty moist air, and rain).

C. Areas for Art Integration

Art designs will be laser etched/cut, routed, milled, carved, inlaid, laminated or otherwise integrated into Accoya wood boardwalk railing panels and seat top panels. Each boardwalk railing panel will be approximately 5.75" W x 6'-16' L x 1" D. Seat top panels are approximately 5.75" W x 16" L x 1" D.

Art Zones include boardwalk railing panels, and seat tops when noted. Zone A is approximately 175-225 square feet. Art Zone B is approximately 238-288 square feet. Art Zone C is approximately 170-220 square feet, including seat tops. Art Zone D is approximately 255-305 square feet. Art Zone E is approximately 258-308 square feet. Art Zone F is approximately 204-254 square feet, including seat tops. Art will be integrated into between 1,300-1,600 square feet of boardwalk railing panels and seat tops. Dimensions and square footage are subject to change as the project's construction documents are finalized.



D. Palm Beach County Parks & Recreation - Background Information

The Palm Beach County Parks Department was created in 1951 as a department under the direction of the County Engineers Office. Reorganization in 1972 led to the separation of Parks and Engineering and so the Palm Beach County Parks and Recreation Department was born. The department steadily expanded during the late 1960s and 1970s. During the 1980s and 1990s, responding to Palm Beach County's exploding population growth and its equally exploding demand for leisure services, aggressive expansion efforts were accomplished. The department is recognized nationally for excellence in park and recreation management, operating 97 park properties spanning more than 8,100 acres and providing organized recreational programs and services for people of all ages and abilities with multiple new and renovated facilities in progress. The Department's mission is "To provide opportunities for healthy, happy living through award-winning parks, welcoming experiences and environmental stewardship". E. Artist Eligibility

Open to all adult Professional Artists with experience designing, fabricating and installing architecturally integrated site-specific art. Professional Artist means a practitioner in the visual arts, generally recognized by critics and/or peers as a professional of serious intent and ability. Indications of a person's status as a Professional Artist include, but are not limited to, income realized through the sole commission of artwork, frequent or consistent art exhibitions, placement of artwork in and/or upon the exterior or grounds of public institutions or museums, receipt of honors and awards, and training in the arts.

F. Budget

Artist who is awarded the contract will receive a maximum fixed fee of \$57,550 inclusive of <u>all</u> expenses to include artist fees, design development with drawings per Florida and International Building Codes, producing digital fabrication files and full size mock-ups of one boardwalk panel and one seat top panel, oversight, coordination, reviews and approvals in fabrication and installation phases along with responding to architect RFIs, and to provide digital professional photograph files of final installed art. Budget includes expenses such as travel, hotel, transportation, mileage, attorney fees, insurance, etc. to complete contract's services

All Artists who are selected to present their concept design proposal to the Finalist Selection Panel will receive a flat fee (honoraria) of \$1,000 inclusive of all expenses.

G. Shortlist Application

1. CODAworx Account Required. To apply for this opportunity, sign up for a free CODAworx account at https://www.codaworx.com/register/ If you already have an account, you can log in. Use one of the following browsers: Chrome, Safari, or Firefox. Click on the person icon in the upper right corner, register with your email address, name and profession.

- **2. Contents of Application.** A complete Shortlist Application must include the following information. <u>Failure to include all of the information listed below may result in disqualification of your application.</u>
 - a. Resume Accepted format: pdf
 - **b. Letter of Interest -** Enter letter content into application's text box
 - Compose or paste a letter expressing your interest in the project and address how your past artwork and experience demonstrate that you can successfully meet art design goals of this project. 4000 words maximum.
 - c. Images of Past Work Image specifications: JPG, PNG, 300dpi, 15MB Max
 - Up to five (5) images of past artwork. Image files may feature one or multiple views per project.
 - Only submit images of completed projects or projects that have been awarded.

Images must contain the following information:

Title of work, location, budget or price, year completed, medium, dimensions

- 3. Evaluation Criteria for Shortlist Selection. Up to three (3) Artists will be short listed based on the following criteria:
 - Demonstrated ability to design, construct and install large scale public art 40 points
 - Quality and strength of past work as demonstrated in the submitted application materials 60 points

4. Shortlist Scoring.

a. Pass/Fail Review. The Shortlist Panel may initially review each application for completeness, Artist experience and prior work and assign either a pass or fail rating. Those applications that receive a pass rating from a majority of the panel will then be scored and ranked by the Shortlist Panel.

b. Ranking. For each application that receives a pass rating from a majority of the panel, each criteria will be scored and when the scores awarded for all criteria are totaled, the scores will be tabulated and added to achieve the total points awarded to each Artist by each Shortlist Panel member. Using the total points awarded to each Artist, each Artist will be ranked by each Shortlist Panel member with the highest point total ranked 1, the next highest point total ranked 2, etc. The ranking of each Artist will be tabulated from each Shortlist Panel member and combined with other Shortlist Panel members to determine the total ranking score for the Artist, with the lowest point total ranked 1, the next lowest point total ranked 2, etc. These rankings will then be used by the Shortlist Panel to shortlist up to three (3) Artists. Should the ranking result in a tie, then the Shortlist Panel will select the Artist with the most first place votes; if there is still a tie, then the Artist with the most second place votes etc. until the Shortlist consists of just three (3) Artists.

H. Mandatory Pre-Proposal Virtual Meeting for Shortlist Artists

Following Shortlist Selection, PBC AiPP will host a mandatory virtual meeting to provide Shortlist Artists additional information and instructions. This is also an opportunity for Shortlist Artists to ask questions of the Project Team. Virtual meeting tentative date is noted in the tentative schedule below. Prior to the mandatory pre-proposal virtual meeting, Shortlisted Artists will receive Construction Documents upon execution of a Non-Disclosure Agreement (NDA) since plans for County buildings are considered confidential information under State law.

Prior to the Pre-Proposal virtual meeting, Shortlist Artists will also receive a Business Information Form which must be completed and submitted to the PBC AiPP along with proof that the Artist's business entity is registered to do business in the State of Florida as either a Florida or a foreign company, or proof that the registration application has been submitted and is pending review.

- 1. Register your business entity at <u>Corporations Division of Corporations Florida Department of State</u> (myflorida.com)
- 2. Provide PBC AiPP with the Business Information Form and proof that your business entity is registered, or the registration application has been submitted to the Florida Department of State.

Shortlist Artists who do not attend the mandatory pre-proposal virtual meeting will be disqualified and will not receive the \$1,000 honoraria.

I. VSS Registration for Shortlist Artists

In order for a Shortlist Artist to receive the \$1,000 honoraria, a Shortlist Artist must register with the County's Vendor Self Service ("VSS") system at https://pbcvssp.co.palm-beach.fl.us/webapp/vssp/AltSelfService.

J. Finalist Selection

- 1. Presentation. Shortlist Artists will develop and present to the Finalist Selection Panel one (1) concept art design proposal. Finalists will have the option to present their presentations in person or virtually to the Finalist Selection Panel. PBC AiPP will provide the Finalist Selection meeting invitation and link one week prior to the Finalist Selection meeting for any Shortlist Artist opting to present virtually. All concept art proposals must address the art design goals. Each Shortlist Artist will have fifteen (15) minutes to present his/her concept to the Finalist Selection Panel followed by questions from the Panel.
- **2. Contents of Finalist Submittal.** A complete Finalist Submittal must include the following information. <u>Failure to include all of the required information may result in disqualification.</u>
 - a. Concept Art Design
 - Color concept drawings/renderings

b. Narrative

- Artwork Title
- Artwork Medium
- Artwork Concept Narrative
- If Artist incorporated elements of the proposed Art design in other projects completed by the Artist
 or in other projects awarded to the Artist, Artist shall identify such element(s) and project(s) in the
 Narrative.

c. Schedule

 Include timeline for milestones including Design Development, digital fabrication files, full size mockup of one boardwalk railing panel one and one seat top panel, fabrication and installation coordination and oversight.

d. Budget

The Artist who is awarded the contract will receive a maximum fixed fee of \$57,550 inclusive of all expenses to include artist fees, design development with drawings per Florida and International Building Codes, producing digital fabrication files and full size mock-ups of one boardwalk panel and one seat top panel, oversight, coordination, reviews and approvals in fabrication and installation phases along with responding to architect RFIs, and to provide digital professional photograph files of final installed art. Budget includes expenses such as travel, hotel, transportation, mileage, attorney fees, insurance, etc. to complete contract's services.

e. Certification of Business Location Form

- Only for Shortlist Artists who have a permanent place of business in Palm Beach County prior to the issuance of this "Call to Artists".
- Shortlist Artists will be provided with the Certification of Business Location Form prior to the Mandatory Pre-Proposal Virtual Meeting. A Shortlist Artist with a permanent place of business in Palm Beach County prior to the issuance of this "Call to Artists" must complete this form and include the form and a current Palm Beach County business tax receipt as part of its Finalist Submittal in order to receive 5 local preference points.
- **3. Evaluation Criteria for Finalist Selection.** The Finalist Selection Panel will select artwork based on the following criteria:
 - Artistic merit of the concept art design 45 points
 - Extent to which art concept design meets the art design goals 50 points
 - Local preference. Artists who have a permanent place of business in Palm Beach County 5 points. During Finalist Selection, Shortlist Artists who have a permanent place of business in Palm Beach County will receive 5 points, if the Shortlist Artist submits the Certification of Business Location Form and a current Palm Beach County business tax receipt.
- **4. Finalist Scoring.** For each finalist submittal, each criteria will be scored and when the scores awarded for all criteria are totaled, the scores will be tabulated and added to achieve the total points awarded to each Artist by each Finalist Selection Panel member. Using the total points awarded to each Artist, each Artist will be ranked with the highest point total ranked 1, the next highest point total ranked 2, etc. The ranking of each Artist will be tabulated from each Finalist Selection Panel member and combined with other Finalist Selection Panel members to determine the total ranking score for the Artist, with the lowest point total ranked 1, the next lowest point total ranked 2, etc. Should the ranking result in a tie, then the Finalist Selection Panel will select the Artist with the most first place votes; if there is still a tie, then the Artist with the most second place votes, etc.

K. Selection Panels

Shortlist and Finalist Selection Panels for this Call to Artists are comprised of the County's Public Art Committee members, a representative from the Palm Beach County Parks and Recreation Department, and a representative of the project architectural team BROOKS SCARPA HUBER, led by Jeffrey Huber. The County reserves the right to make changes to the membership of the Shortlist and Finalist Selection Panels if necessary. While not common, the Finalist Selection Panel may request minor changes to the selected art concepts. If a Finalist refuses to make requested minor changes to his/her proposed concept art per the Finalist Selection Panel's request, Palm Beach County may opt not to contract with Artist for the art commission.

Artist whose concept art design(s) are selected by the Finalist Selection Panel will enter into the County's standard form Agreement for Artist Design Services.

Questions regarding this Call to Artists must be directed to Palm Beach County's Public Art Program Administrator, Elayna Toby Singer, at esinger@pbc.gov. If applicants rely on information provided by persons other than Ms. Singer, they do so at their own risk. From the date of release of this Call to Artists until award of contract, no contact with Palm Beach County's Public Art Committee, members of Selection Panels for this Call to Artists, or representatives of Palm Beach County related to this Call to Artists is permitted except as authorized by Ms. Singer and/or in conjunction with scheduled Call to Artists activities. Any such unauthorized contact shall not be used as a basis for selection and may result in the disqualification of the Artist's proposal.

In addition, the Palm Beach County's Lobbyist Registration Ordinance prohibits an Artist or anyone representing an Artist from communicating with any County Commissioner, County Commissioner's staff, or any employee authorized to act on behalf of the Commission to award a particular contract regarding this Call to Artists, i.e., a "Cone of Silence." The "Cone of

Silence" is in effect from the date/time of the deadline of the Shortlist application and terminates at the time that the Board of County Commissioners or a County Department authorized to act on their behalf, awards or approves a contract, rejects all bids, or otherwise takes action which ends the solicitation process. Artists may, however, contact any County Commissioner, County Commissioner's staff, or any employee authorized to act on behalf of the Commission to award a particular contract, via written communication, i.e., facsimile, e-mail, or U.S. mail. Violations of the "Cone of Silence" are punishable by a fine of \$250.00 per violation.

N. Amendments

Changes to this Call to Artists, when deemed necessary by Palm Beach County, will be completed only by written Amendment(s) issued prior to the deadline for receipt of proposals. Proposers should not rely on any representations, statements or explanation other than those made in this Call to Artists, or in any Amendment to this Call to Artists. Where there appears to be a conflict between the Call to Artists, and any Amendment issued, the last Amendment issued shall control.

ALL Palm Beach County Call to Artists and Amendments will be advertised at https://pbcvssp.co.palm-beach.fl.us/webapp/vssp/AltSelfService. It is the sole responsibility of Artists/proposers to routinely check this website for any Amendments issued prior to the deadline for receipt of proposals. Palm Beach County shall not be responsible for the completeness of any package (Call to Artists and Amendments) not downloaded from these websites.

O. General Terms and Conditions

- 1. Florida Public Records Law. Upon submission, all proposals become public records and the property of Palm Beach County, and subject to disclosure in accordance with Florida law.
- 2. **Due Diligence of Proposer.** Due care and diligence has been exercised in preparation of this Call to Artists and all information contained herein is believed to be substantially correct; however, the responsibility for determining the full extent of the requested services rests solely with those making proposals.
- 3. Rejection of Responses; Waiver of Irregularities. Palm Beach County reserves the right to reject any or all proposals submitted in response to this Call to Artists, waive any or all informalities and/or irregularities, re-advertise with either an identical or revised scope, or cancel this Call to Artists in its entirety, at its sole and absolute discretion. Palm Beach County is not under any obligation to select Shortlist Artists or a Finalist or to award a contract if, in the sole judgment of the County, the Artist materials do not meet the eligibility or qualifications for the project.
- **4. Right to Reschedule or Cancel.** Palm Beach County reserves the right to reschedule or cancel Finalist Selection without paying expenses.
- **Clarifications.** Palm Beach County reserves the right to contact any or all proposers after submittal in order to obtain supplemental information and/or clarification in either verbal or written form.
- **Registration To Do Business In the State of Florida.** The selected Artist's business entity must be registered to do business in the State of Florida with the Florida Department of State.
- 7. **County Standard Contract Required.** The selected Artist will be required to execute the County's standard contract for Artist's services. A copy of this document is available upon request.
- **8. Public Entities Crimes/Convicted Vendor List.** Per Florida Statute 287.133, a person or affiliate who has been placed on the State of Florida convicted vendor list following a conviction for a public entity crime may not submit a response to a solicitation for a period of 36 months from the date of being placed on the convicted vendor list. Proposers suspended from doing business with the County at the time this solicitation is advertised are not eligible to submit a response.
- 9. Non-Discrimination. The County is committed to assuring equal opportunity in the award of contracts and complies with all laws prohibiting discrimination. Pursuant to Palm Beach County ResolutionR2025-0748, as may be amended, the proposer warrants and represents that throughout the term of any resulting Contract, including any renewals thereof, if applicable, all of its employees are treated equally during employment without regard to race, color, religion, disability, sex, age, national origin, ancestry, marital status, familial status, sexual orientation, or genetic information. Failure to meet this requirement shall be considered default

of any resulting Contract.

10. Prohibition against Considering Social, Political or Ideological Interests in Government Contracting - F.S. 287.05701. Proposers are hereby notified of the provisions of section 287.05701, Florida Statutes, as amended, that the County will not request documentation of or consider a Proposer's social, political, or ideological interests when determining if the Proposer is a responsible Proposer. Proposers are further notified that the County's governing body may not give preference to a Proposer based on the Proposer's social, political, or ideological interests.

P. Award of Contract

1. Notification of Recommended Award. Artists will be notified of the recommended award by email and the Notification will be posted for 5 business days on the following website: http://discover.pbcgov.org/fdo/art/Pages/Calls-to-Artists.aspx.

2. Right of Appeal/Protest.

- a. Responsiveness Review and/or Shortlist Results. Any Proposer may appeal/protest the responsiveness review and/or shortlist results by submitting a written protest to the Director, Facilities Development and Operations Department within five (5) business days after receiving notice from the Department of the results of the responsiveness review and/or Shortlist Panel evaluation. Protests must be submitted in writing, must identify the protestor and the solicitation, must describe the grounds for the protest, and must be addressed to the Director, Facilities Development and Operations Department, via hand delivery or mail to 2633 Vista Parkway, West Palm Beach, FL 33411 or via email to Jennifer Ferriol Jerriol@pbc.gov. A protest is considered filed when it is received by the Director, FDO. Failure to file a protest within five (5) business days of Artist's receipt of the Department's notice of the results of the responsiveness review and/or Shortlist Panel results shall constitute a waiver of the proposer's right to protest.
- **b. Finalist Selection**. Any Proposer may appeal/protest a final selection by submitting a written protest to the Director, Facilities Development and Operations Department within five (5) business days after the posting of the Notice of Intent to Award by the Department. Protests must be submitted in writing, must identify the protestor and the solicitation, must describe the grounds for the protest, and must be addressed to the Director, Facilities Development and Operations Department, via hand delivery or mail to 2633 Vista Parkway, West Palm Beach, FL 33411 or via email to JFerriol@pbc.gov. A protest is considered filed when it is received by the Director, FDO. Failure to file a protest within five (5) business days of the posting of the Notice of Intent to Award shall constitute a waiver of the proposer's right to protest.
- **3. Negotiations.** The County will conduct negotiations with the highest ranked Artist. However, if an agreement is not reached with the top ranked Artist, negotiations will be terminated, and the County will move to the second ranked Artist to attempt to reach agreement. If an agreement is not reached with the second-ranked Artist, the County will move to the third-ranked Artist.
- **4. Cancellation of Recommended Award.** The County reserves the right to cancel the recommended award of any contract at any time before the execution of said contract by all parties without liability against the County. The proposer, by submitting a proposal, expressly waives any claims to damages of any kind whatsoever in the event the County exercises its rights under this subsection.
