The Countywide Geographic Information System (CWGIS) in Palm Beach County includes the technical infrastructure, applications, human resources, and GIS data. These systems constitute the Enterprise GIS (EGIS) used by agencies that access the County's wide area network (WAN). The infrastructure is in place for local government to utilize geographic and land data to support informed decision making, cost efficiency and responsible management.

CWGIS also promotes enhanced taxpayer benefits through efficient information access. By facilitating citizen access to government data and providing timely answers and feedback, government can be strategically directed to respond to the needs of the taxpayers.

Government can stimulate productive business partnerships by being more market and enterprise oriented. Examples of this include data sharing partnerships with municipalities and other public entities, as well as the annual South Florida GIS Expo, which operates as a public/private partnership.

Palm Beach County has built its EGIS on the foundation of a strong organizational model and technical innovation. The use of GIS as an embedded, transparent part of business processes is unique and powerful.


