The Town of Lake Clarke Shores wishes to introduce, for consideration by the Florida Legislature, a Local Bill, which declares the unincorporated geographic are within our Town boundaries as an enclave.

As stated in s. 171.046, Florida Statutes, "enclaves can create significant problems in planning, growth management and service delivery", which is why the Florida legislature has declared that "it is the policy of the state to eliminate enclaves."

Because the western boundary of the Town of Lake Clarke Shores is Florida Mango, which is a county roadway, the Town must seek an exemption from the statute definition of an enclave through the filing of a Local Bill.

Town of Lake Clarke Shores Local Bill SUMMARY FACT SHEET

2022 Legislative Session

The Town of Lake Clarke Shores is eliminating an enclave within the boundaries of the Town, which is currently part of unincorporated Palm Beach County.

Section 1. Declares the legal description of the geographic portion of unincorporated Palm Beach County that is within the Town boundary, to be wholly and completely within the Town boundaries on all side, and therefore meets the definition of an enclave.

Explanation - Enclave areas are defined in chapter 171, Florida Statutes, to mean any unincorporated improved or developed area that is enclosed within and bounded on all sides by a single municipality. Unfortunately, the statute does not address the unique boundary exception in this particular circumstance, which is the county roadway, Florida Mango.

The declaration serves as an exemption to the statutory definition of an enclave.

Section 2. Declares that for the purpose of municipal annexation, the unincorporated portion of Palm Beach County within the Town boundaries, is an enclave.

Explanation - The declaration does not automatically annex the enclave into the Town, but by declaring the unincorporated area an enclave, the Town and the County may proceed to consider the area as an enclave and therefore, subject to the same procedures for elimination of an enclave.

Section 3. Effective date will be upon becoming law.
