## Countywide Community Revitalization Team VIRTUAL MEETING





Join our featured guest speakers and the Countywide Community Revitalization Team (CCRT) for a virtual WebEx meeting hosted by the Office of Community Revitalization (OCR) on Thursday, June 10, at 10 a.m.

Randee Gabriel, Program Manager, 211 HelpLine, will be in attendance to talk about the 211 Palm Beach/Treasure Coast mission and services. 211 Palm Beach/Treasure Coast's mission is to save and improve lives through crisis intervention, understanding their individual needs, and by connecting people to health, mental health, and wellness services 24 hours a day every day. It is a confidential community helpline and crisis hotline that provides immediate guidance and support for individuals and families who find themselves without answers to problems they may face on a daily basis. 211 provides information on available resources and an array of support services, including but not limited to: telephone counseling, suicide prevention, crisis intervention, assessment, and referral to community services for people of all ages. As the central gateway to health and human services, 211 collects, maintains, and makes available up-to-date resource information via phone, text, email, website, printed guides and directories.

Diana Coho, Consumer Affairs and Outreach Specialist Federal Communications Commission (FCC), will be also in attendance to talk about the Emergency Broadband Benefit (EBB) Program. The FCC has launched this temporary program to help families and households struggling to afford Internet service during the COVID-19 pandemic. The program provides eligible households with a monthly discount toward broadband service and a one-time discount to purchase a laptop, desktop computer, or tablet from participating providers. This presentation will explain who is eligible for this benefit, three ways to apply, and where to find multimedia outreach materials about this program.
