The purpose of this memorandum is to provide a summary of the items discussed at the March 10th CCRT meeting. The items along with the responses for each item are provided below.

1) Stacey Street

- ➤ Brenda Warren, Royal Palm Estates resident, requested the status of the street improvement project on Stacey Street.
 - Based on information provided by Palm Beach County Construction Coordination Department, the preconstruction conference for this project was held on April 8th. The project construction will begin by the end of this month (April). The completion date for the project is unknown. 2) Royal Palm Estates

- ➤ Brendhan Horne, Royal Palm Estates resident, requested an update on the streetlight project.
 - On April 7th, FPL advised the installation for this project will commence in late May or early June.
- ➤ Brendhan Horne, Royal Palm Estates resident, requested an update on the signs for the park.
 - Dan Weisberg, Director of Traffic Engineering, advised that Kids/Children at Play signs could not be installed but that Playground signs could. On 04/10/09, Mr. Weisberg advised that the signs will be installed by the end of April or in early May.



- Brendhan Horne, Royal Palm Estates resident, requested an update on the Pathway Project.
 - Based on the information provided by Cornelia Tobalski, Palm Beach County Engineering and Public Works, the three (3) projects below were included in the FY 08/09 Pathway Program approved by the BCC on 11/18/08. They have to resolve some design issues before they can be built. The pathways will be 6'-wide asphalt.
 - 1. Avocado Ave. from Southern Blvd. to Papaya Rd.
 - 2. Caroline Dr. from Southern Blvd. to Papaya Rd.
 - 3. Papaya Rd. from Pine Ave. to the E-3 Canal
