I. WELCOME AND INTRODUCTION:

Duane Gainer introduced himself and asked meeting participants to take a moment of silence for the victims of 911, and asked to introduce themselves.

Mr. Gainer stated that there were no follow-ups from the August 14, 2007 CCRT meeting.

III. PRESENTATION: Gloria Zimmerman Area Agency On Aging

Next, Mr. Gainer informed the group that Gloria Zimmerman, Area Agency on Aging, would talk about the programs available.

Ms. Zimmerman stated that primarily the agency is in support of volunteer programs and is looking for several volunteers to work, she also mentioned that the organization covers Palm Beach County, Martin County, St. Lucie County, Indian River, and Okeechobee County. The agency has an office in West Palm Beach, and Ft. Pierce.

Ms. Zimmerman began to talk about the following programs that the organization have available:

- 1. <u>Foster Grandparent Program</u> In this program senior citizens are hired to work in schools with children. They work in the elementary schools throughout the five county areas.
- 2. <u>Leadership Institute for Active Aging</u>. This program is for seniors that want to take on the leadership role recruiting for fall classes.
- 3. <u>Retired Senior Volunteer Program</u> This involves certain needs and currently there 4000 volunteers work in schools, hospitals, citizens on patrol, office work, & etc
- 4. <u>Community Emergency Response Team county</u> trains to be certified
- 5. <u>Senior Crime Victim Intervention and Prevention</u> This program is for senior citizens that are victims of robbery, burglary, larceny, exploitation, and domestic abuse. The advocates that work in this program work closely with the Sheriff's Office and the State Attorney General Office to work with seniors that have been victims of crime.
- 6. <u>Serving Health Insurance Needs of Elders (SHINE)</u> volunteers provide free inperson counseling and information about your health insurance coverage. Supplement prescription cost. is a program at no cost to elders? Specially Trained Volunteers can assist with Medicare, Medicaid and Health Insurance issues by providing information, answering questions and helping resolved problems.
- 7. Emergency Readiness and Response
- 211 Provides telephone counseling to help people through personal problems, emotional stress, and such emergencies Provides information and linkage for people in need of various human services available in the area.

Ms. Zimmerman stated there are services available for you if you are over the age of 60 and need assistance. Volunteer opportunities are available for younger people.

Roan Lane Extended-Stay Hotel
