Join the Countywide Community Revitalization Team (CCRT) for a virtual WebEx meeting hosted by the Office of Community Revitalization (OCR) on Tuesday, September 20, at 10 a.m.

Countywide Community Revitalization Team (CCRT) members and OCR staff will provide an update on projects currently underway and/or planned to address community needs.

This month's guest speaker **Aleshia Coleman, M.Ed., Program Planner** with the School District of Palm Beach County Department of Safe Schools McKinney-Vento Program (MVP), will be in attendance to talk about the MVP. The program ensures compliance with the McKinney-Vento Homeless Education Assistance Act, the chief piece of federal legislation protecting the educational rights of homeless children and youth. The mission of the MVP team is to work collaboratively with all stakeholders to remove barriers to successful outcomes for homeless students. The MVP team comprises the Program Planner, a Homeless Liaison, an Academic Support Specialist, and 11 McKinney-Vento Case Managers who coordinate with schools, parents, families, and myriad community partners to ensure a successful educational experience for homeless children and youth. The removal of barriers often faced by students experiencing homelessness in enrolling, attending, and succeeding in school is paramount. Through collaboration activities, doors are opened to academic opportunities, school stability, and overall student success.

This public meeting is a great opportunity for neighborhood residents to network with county agencies, OCR partners, and other community leaders who are making a difference in Palm Beach County neighborhoods.
