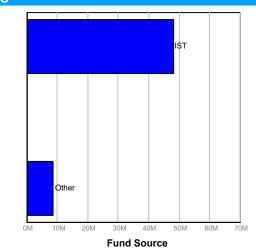

All 3 levels continue to progress. The punch-out process is 90% complete. Stocking permit is in place. Final exterior punch-out walk will be 6/30/23. Exterior camera wiring is complete, parking lot sealing is underway, final roof inspection is complete, and civil/ landscape is 95% complete. Interior work includes: 3 of 5 of the new elevators have been inspected and tuned over to PBC. Remaining two elevators 17 and 18 are in progress with final connections in progress and expected to be completed by 7/14/23. Doors complete. Access control hardware is 85% complete. Project schedule risks include HVAC electronic controllers and communication cabling failure. Owner acceptance and turnover are expected in late- July 2023. Kast is expected to be clear of the site by 8/14/23.
