3. Approve Minutes – August 15, 2024

4. Revenue Report

Mr. Carrier stated that 6th Avenue South bridge had recently been opened.

b. Parks and Recreation

Mr. Hamilton provided a slideshow presentation of the Canal Point Community Center redevelopment project.

Mr. Kirby expressed concerns about renovations impacting an old sewer line and Mr. Hamilton responded, explaining that due to the building's age sewer line replacements may be required.

c. FD&O

Mr. McClellan provided a status update via slideshow presentation on the 810 Datura Building Replacement project and the 45th Street Complex Master Plan.

Mr. Smith inquired about new burials at the historic cemetery and Mr. McClellan explained that another county department has a program in place for alternative burial arrangements.
