

Cone of Silence

As a reminder, the Cone of Silence remains in place. "Cone of Silence" means a prohibition on any non-written communication regarding this Notification of Funding Opportunity between any Proposer or Proposer's representative and any County Commissioner or Commissioner's staff. A Proposer's representative shall include, but not be limited to, the Proposer's employee, partner, officer, director or consultant, lobbyist, or any, actual or potential subcontractor or consultant of the Proposer.

Right of Appeal/Protest

As a reminder, any Proposer may protest the Recommended Subrecipient Awards by submitting a written protest to Stephanie Sejnoha, Director of the Public Safety Department, within five (5) business days of the posting of the Recommended Subrecipient Awards.

The protest shall be submitted in writing, shall identify the protestor and the solicitation, shall include a factual summary of the basis for the protest, and shall be addressed to the Director of the Public Safety Department, via hand-delivery, via mail to 50 S. Military Trail, West Palm Beach, FL 33415, or via email to ssejnoha@pbcgov.org and reference in the subject line: NoFO Adult Post-Release Reentry Services Protest. A protest is considered filed when it is received by the Director of the Public Safety Department.

Failure to file a protest within five (5) business days of the posting of the Recommended Subrecipient Awards shall constitute a waiver of the Proposer's right to protest.
