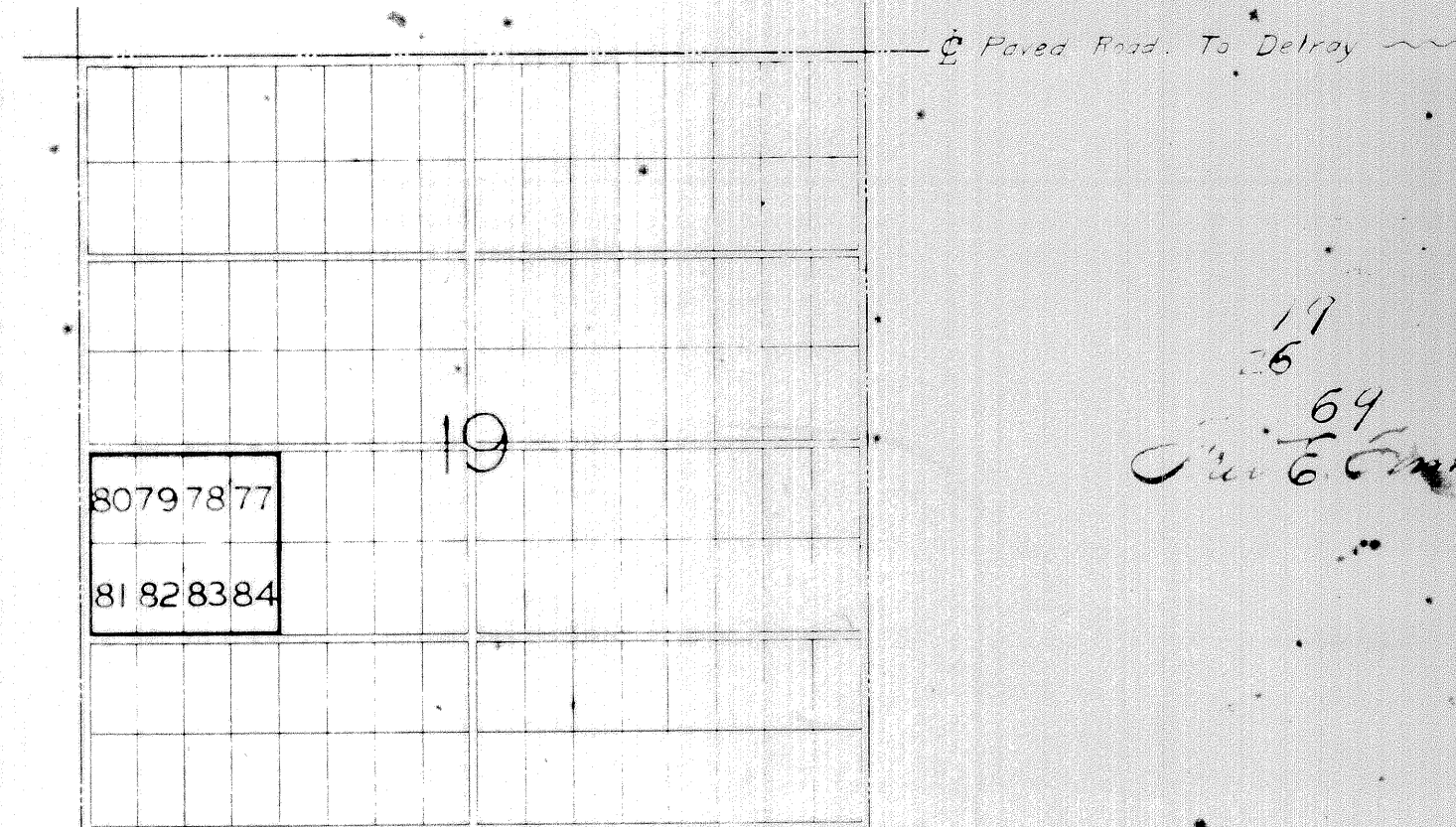

LOCATION SKETCH



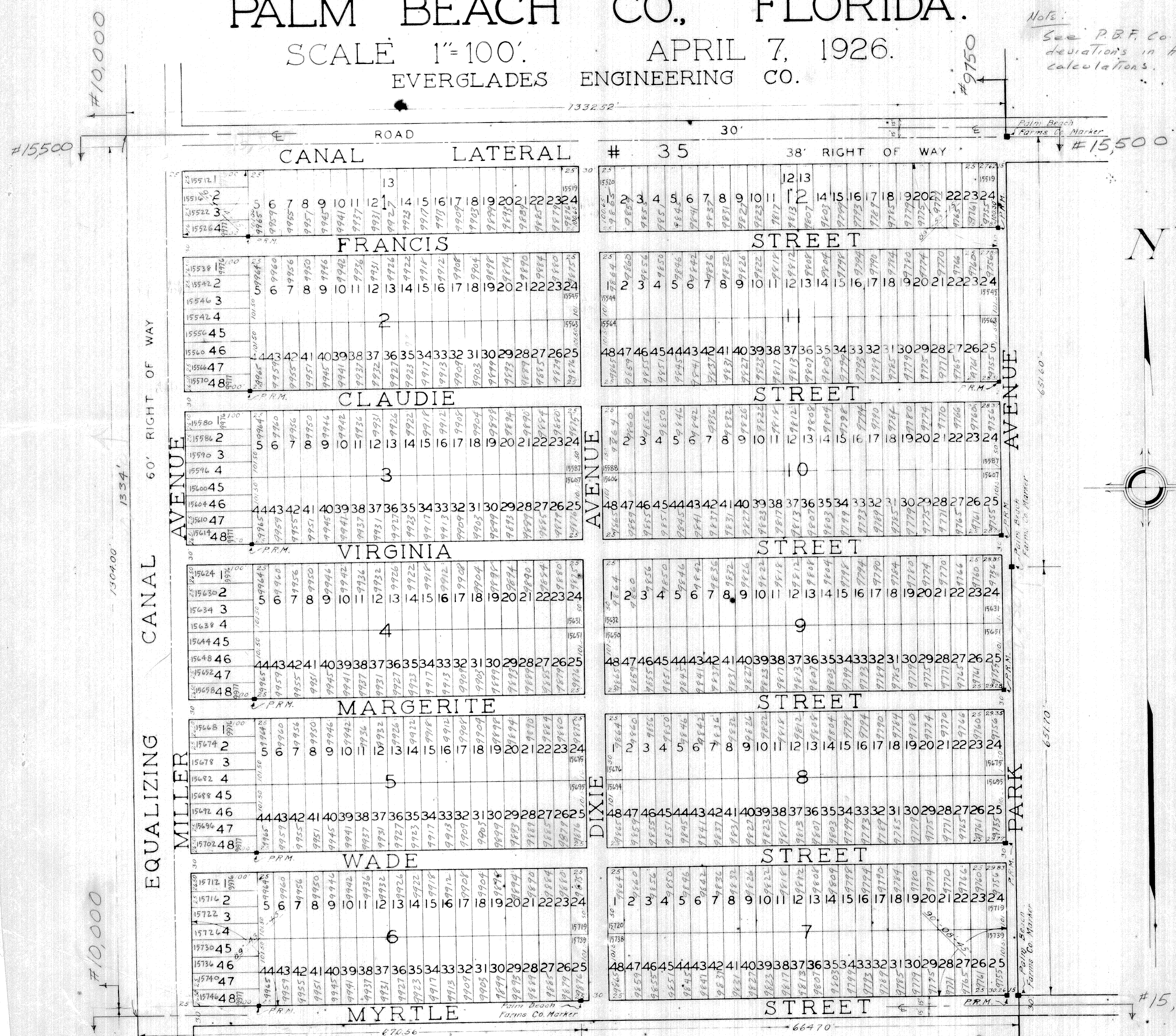
