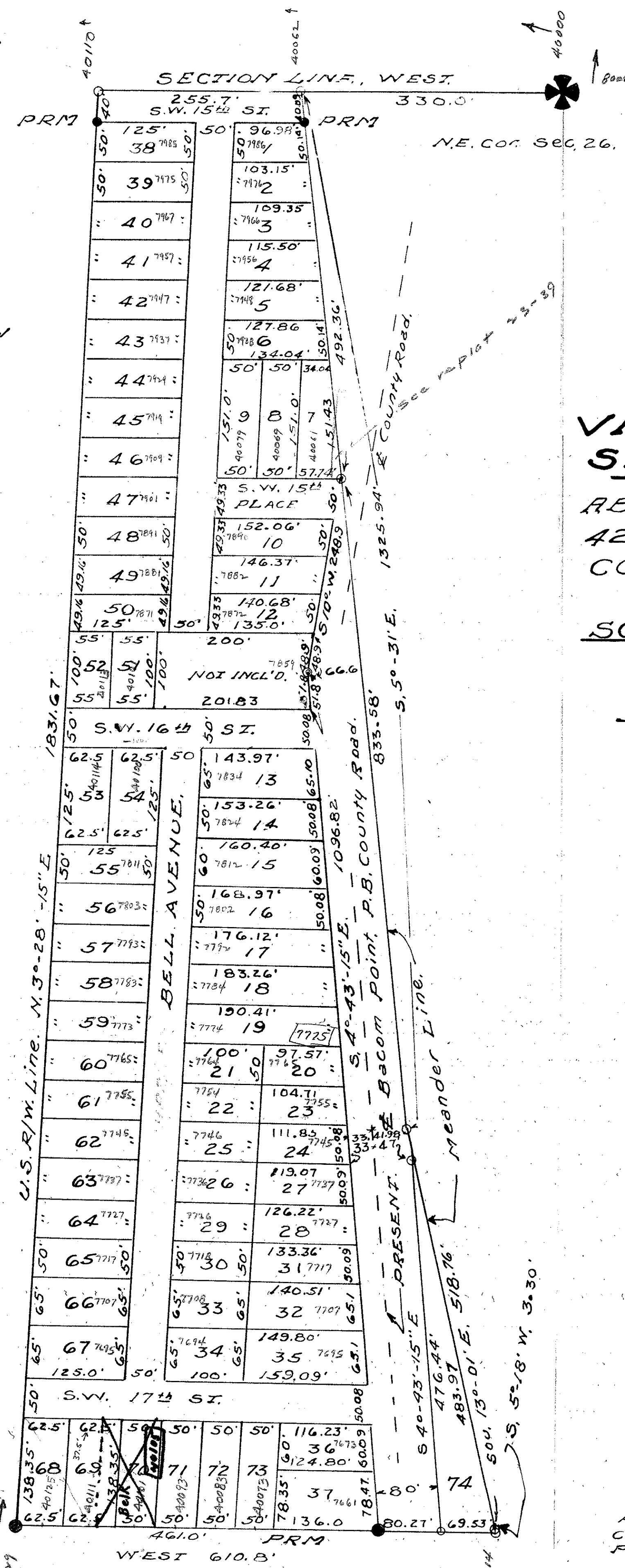

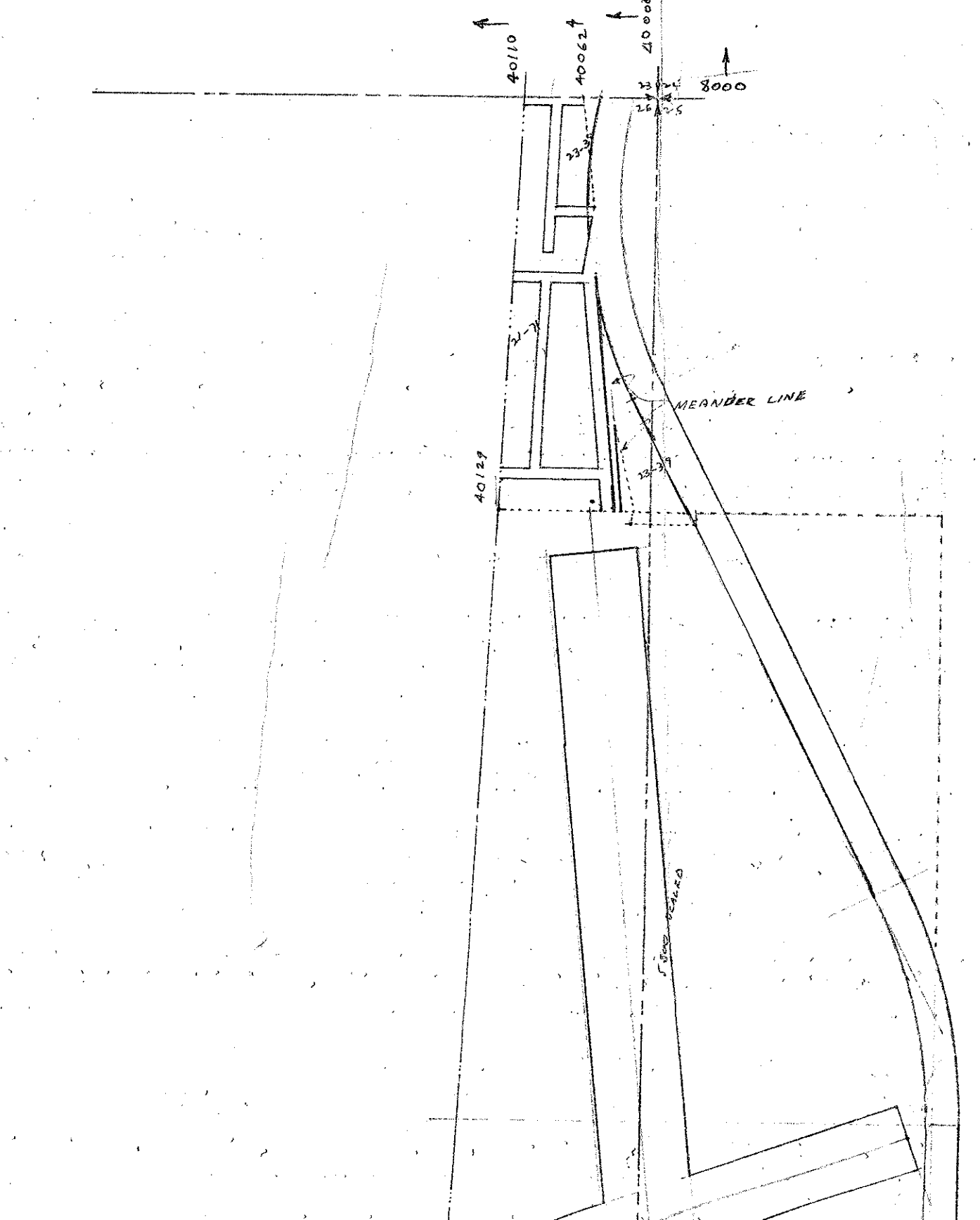


**VICTOR L. GEIGER'S,
