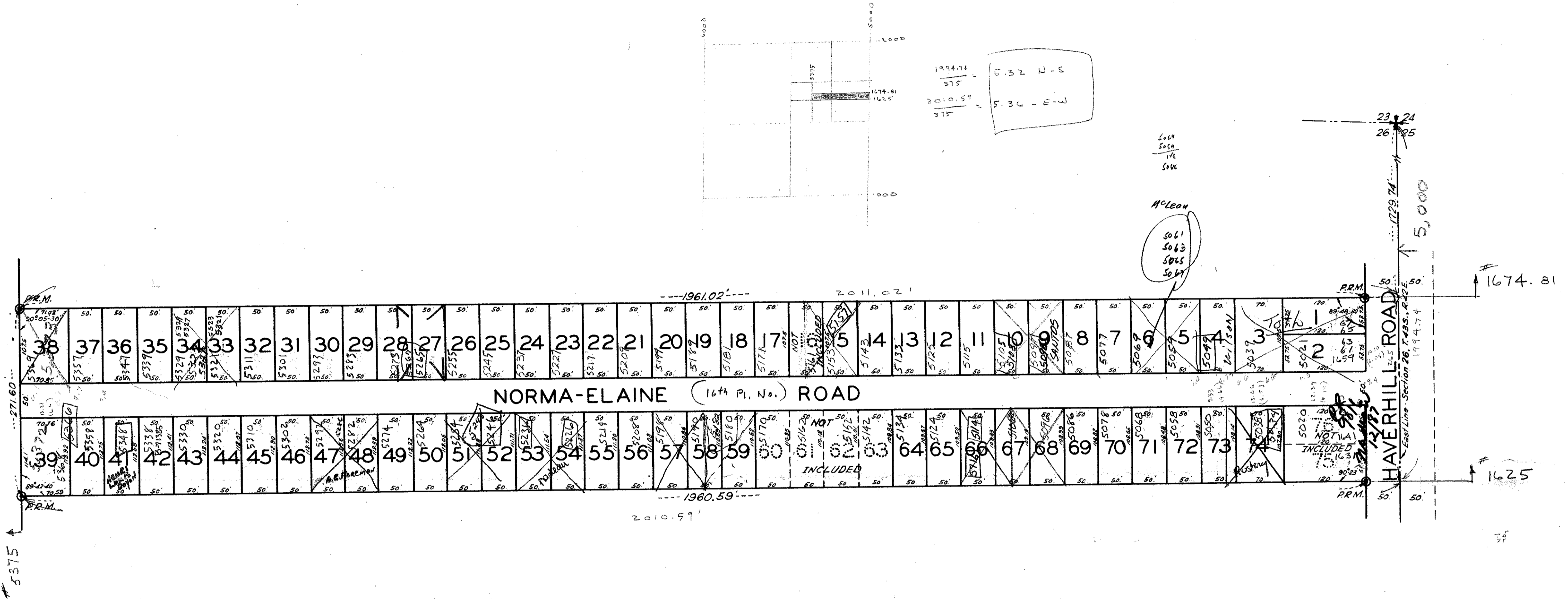

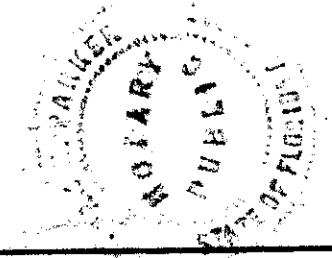

described as:  
The Northeast Quarter (NE 1/4) of the Southwest Quarter (SW 1/4) of the Northeast Quarter (NE 1/4)  
less the North 400 feet and the North 1/2 of the Southeast Quarter (SE 1/4) of the Northeast Quarter  
(NE 1/4) less the North 400 feet, all being in Section 26, Township 43 South, Range 42 East, Palm  
Beach County, Florida.  
have caused the same to be surveyed and platted as shown hereon, and hereby dedicate to the  
perpetual use of the public, the road as shown, reserving however unto themselves, their heirs, assigns or  
legal representatives, the reversion thereof whenever the same shall be abandoned by the public  
or discontinued by law.  
AN EASEMENT FOR PUBLIC UTILITIES is reserved over and under the rear 25 ft. of all lots.
