

KNOW ALL MEN BY THESE PRESENTS, that C. C. TOWNES and his wife, ROSE A. TOWNES, the owners of the tract of land lying and being in Palm Beach County, Florida, shown hereon, and more particularly described as follows, to wit:

Beginning at the intersection of the North Line of Section 10, Town-ship 42 South, Range 43 East and the east shore of Lake Worth; thence easterly along the North Line of said Section 10, a distance of 1476 feet, more or less, to the waters of a Lagoon; thence southerly along the waters of said Lagoon to a point in a line parallel to, and 303.6 feet south of (measured at right angles) the North Line of said Section 10; thence westerly along said parallel line, a distance of 1390 feet, more or less, to the east shore of Lake Worth; thence northerly along the waters of Lake Worth to the point of beginning.
