KNOW ALL MEN BY THESE PRESENTS: LIONEL E. SAMUELS and his wife, GERTRUDE M. SAMUELS, owners in fee simple of that tract of land lying and being in Palm Beach County, Florida, shown hereon as "HARTLEY PARK" and more particularly described as follows, to wit:

"A part of the southeast quarter (1/4) of the northeast quarter (1/4) of the southwest quarter (1/4) of section thirty-six (36), Township forty-three (43) South, Range forty-two (42) East, Palm Beach County, Florida,"

have caused the same to be surveyed and platted as shown hereon, and do hereby dedicate to the perpetual use of the public as public highways the streets, roads and trails shown on this plat, reserving however, unto themselves, their heirs, successors, assigns or legal representatives, the reversion or reversions thereof whenever the same shall be abandoned or discontinued by law.

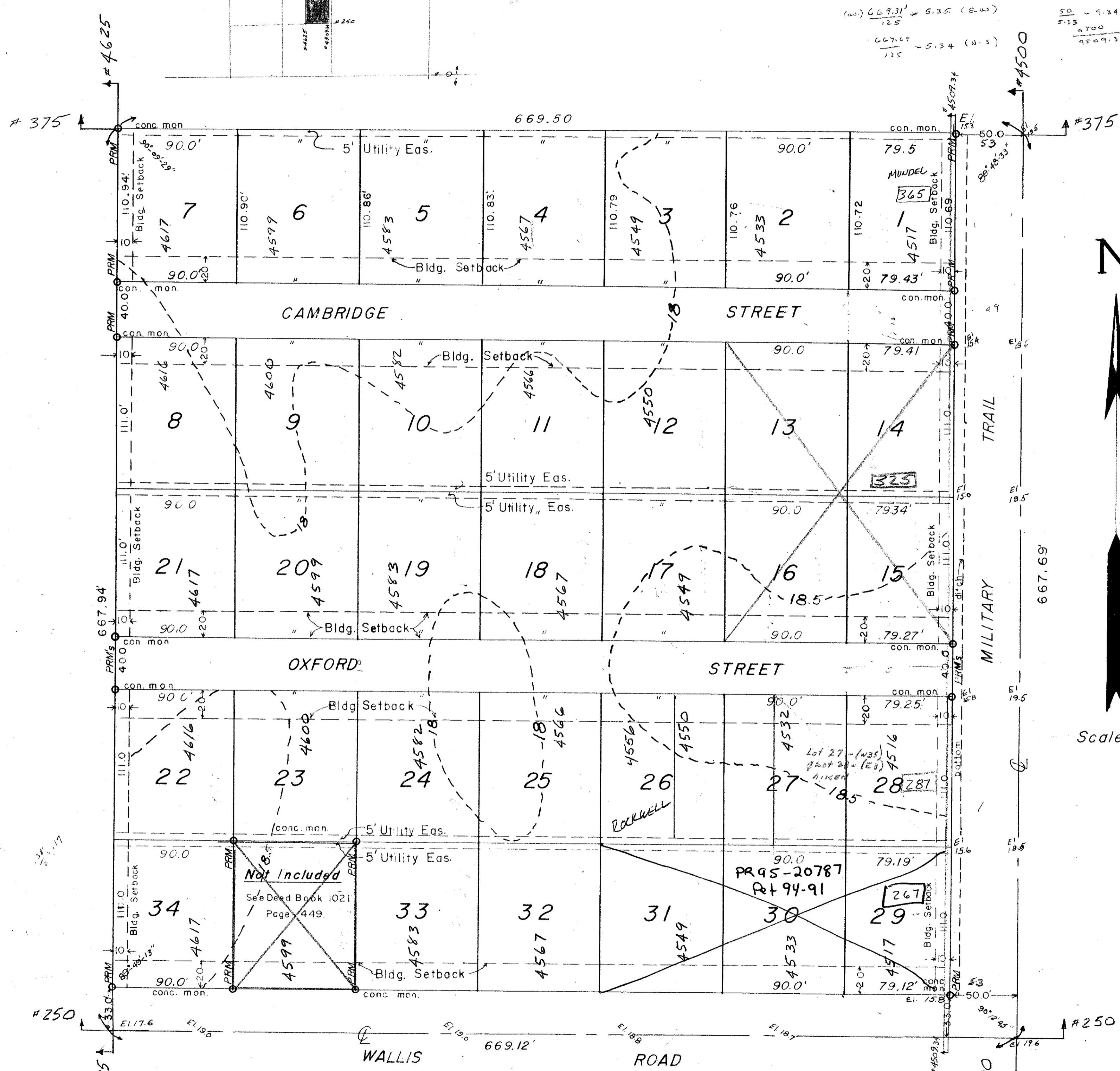
