

KNOW ALL MEN BY THE'SE PRESENTS, that BELVEDERE DEVELOPMENT CO. and PALM BEACH KENNEL CLUB, INC., Corporations organized and existing under the laws of the State of Florida, the owners of the tract of land lying and being in Palm Beach County, Florida, shown hereon, and more particularly described as follows, to wit:

> Beginning at the Northeast Corner of the Southeast Quarter (SE1/4) of Section 30, Township 43 South, Range 43 East; thence westerly along the North Line of the Southeast Quarter (SE1/4) of said Section 30, a distance of 895.16 feet to a point in a line parallel to, and 50 feet west of, the East Line of the West Three Quarters ($W^{3/4}$) of the Northwest Quarter (NW1/4) of the Northeast Quarter (NE1/4) of the Southeast Quarter (SE1/4) of said Section 30, thence southerly along said parallel line 315 feet to a point in a line parallel to, and 315 feet south of, the North Line of the Southeast Quarter (SE1/4) of said Section 30; thence easterly along the last described parallel line 894.7 feet to the East Line of said Section 30; thence northerly along the East Line of said Section 30 to the point of beginning. Subject to the existing Right of Ways of the Lake Worth Drainage District, Congress Avenue and the Right of Way of the United States Government as described in Deed Book 856, page 30, Palm Beach County Records.
