KNOW ALL MEN BY THESE PRESENTS, that MEMORY GARDENS, INC., a corporation organized and existing under the laws of the State of Florida, the owner in fee simple of the tract of land lying and being in Palm Beach County, Florida, shown on the attached plat as MEMORY GARDENS, more particularly described as follows, to wit: North half (N 1/2) of Tract thirty-two (32) in the Model Land Co. subdivision of Section twenty-four (Sec. 24), Township forty-four South (T. 44 S.), Range forty-two East (R. 42 E.), less any easements or right-of-ways for canals or roads, containing twenty acres (20 A.) more or less; as recorded in Plat Book five, Page seventy-six (P.B. 5, P. 76), in the Office of the Clerk of the Circuit Court in and for Palm Beach County, Florida; and does hereby dedicate to the perpetual use of the public as public highways the East forty feet (40 ft.) thereof as Kirk Road and the South forty feet (40 ft.) thereof as Tenth Avenue, both being County road right-of-ways as shown on attached plat; reserving however unto itself, its successors, assigns or legal representatives, the reversion or reversions thereof whenever the same shall be abandoned by the public or discontinued by law.
