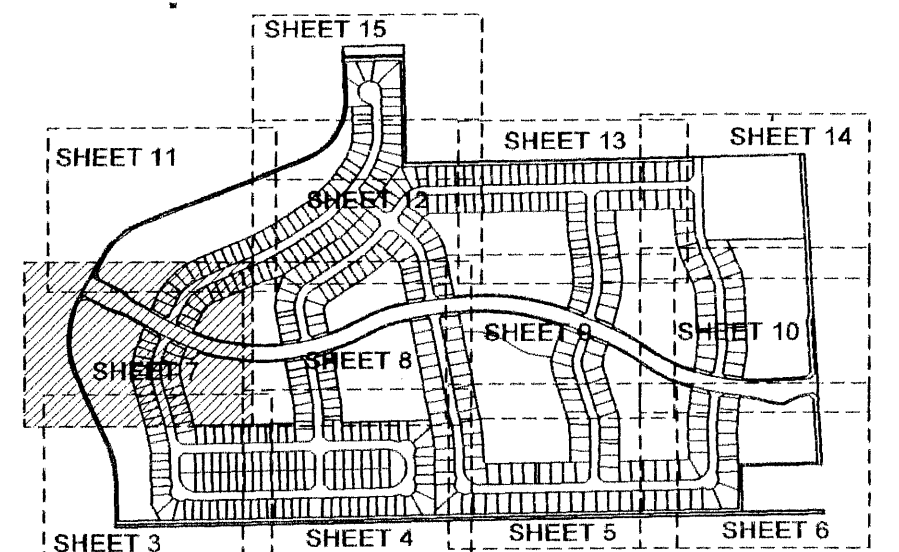
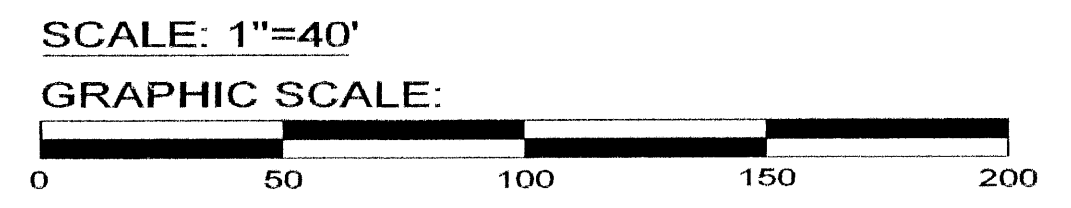
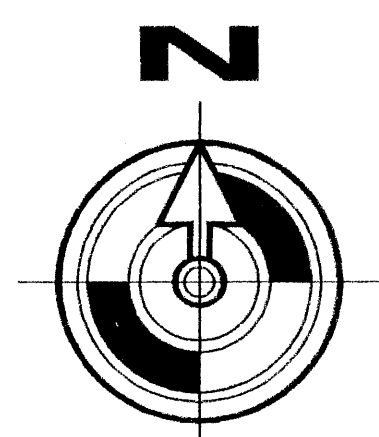

2. BEARINGS AND COORDINATES, SHOWN HEREON, ARE BASED UPON THE STATE PLANE COORDINATE SYSTEM TRANSVERSE MERCATOR FLORIDA EAST ZONE, 1983 PROJECTION, WITH THE NAD 1990 ADJUSTMENT - AS ESTABLISHED BETWEEN C.P.S. CONTROL STATIONS "PBF-13" AND "PBF-14", HAVING A GRID BEARING OF S. 01°40'37" E. - (THE SCALE FACTOR USED IS 1.000030). BEARINGS SHOWN ARE GRID BEARING, DISTANCES SHOWN ARE GROUND DISTANCE.

6. THE BUILDING SETBACKS AND SITE REGULATIONS SHALL COMPLY WITH THE APPROVED MASTER PLAN.
