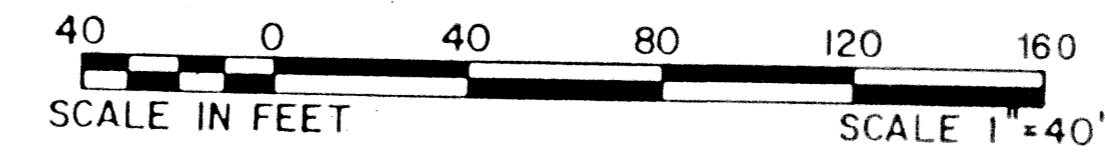

RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, CHANGING THE STREET NAME OF LAKE BREEZE DRIVE LOCATED IN WELLINGTON P.U.D. TRACT 43 AS RECORDED IN P.B. 59 PAGES 68-71 PUBLIC RECORDS OF PALM BEACH COUNTY, TO DEL RIO DRIVE

WHEREAS, the Board of County Commissioners of Palm Beach County, Florida, is authorized under Section 36.05, Florida Statutes, to name and rename streets and roads lying outside the boundaries of any incorporated municipality; and

WHEREAS, the Board of County Commissioners of Palm Beach County, Florida, has, by Resolution No. R-74-183 adopted a system of street naming and numbering for Palm Beach County, and

WHEREAS, the Board of County Commissioners has been made aware of a condition in which duplication exists, and

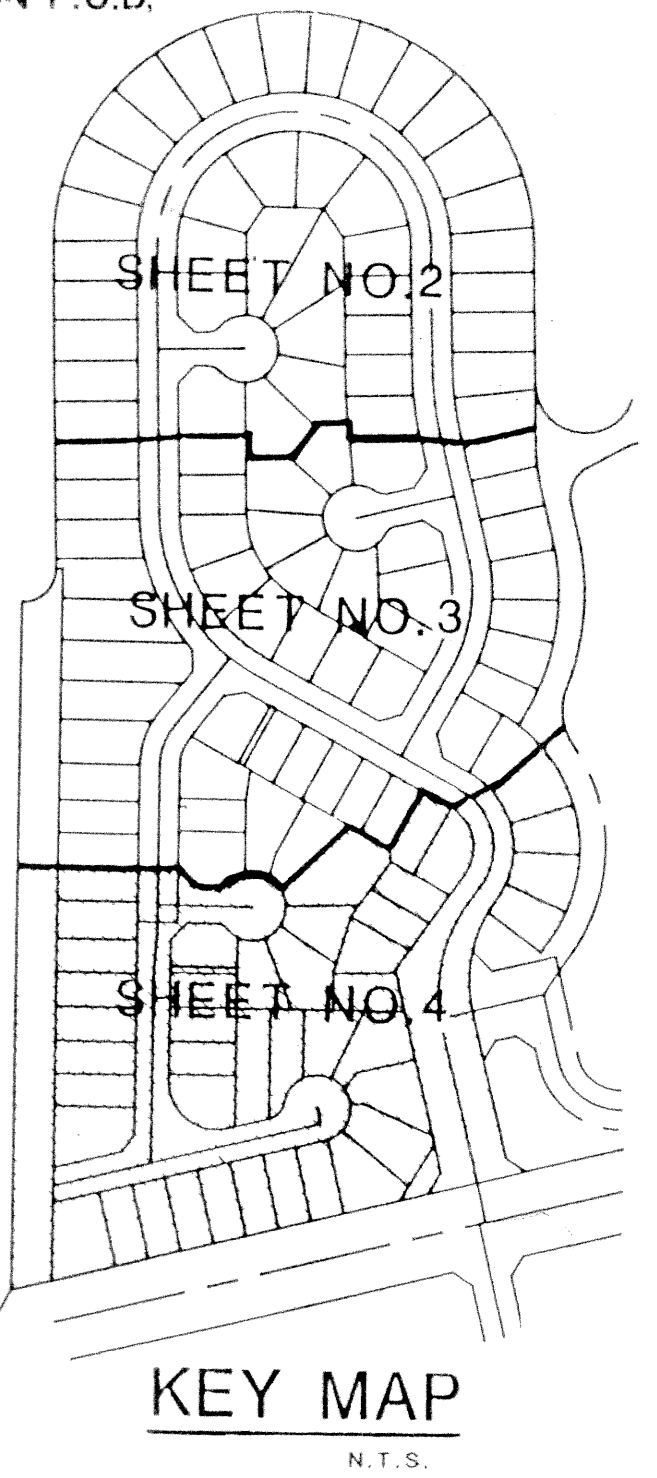
WHEREAS, the Planning Division of the Palm Beach County Planning, Zoning, and Building Department has reviewed the situation and finds that such duplication exists and that the proposed name DEL RIO DRIVE does not duplicate any other name in the unincorporated area of Palm Beach County

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, assembled in regular session this 28th day of August, 1990, that:

- The street name of LAKE BREEZE DRIVE on that roadway delineated on the accompanying map and recorded in the Public Records of Palm Beach County, is hereby changed and the street shall now be known as DEL RIO DRIVE.
- All appropriate agencies shall be notified by the Planning Division of the Palm Beach County Planning, Zoning, and Building Department of such official change.
- The affected plat and/or plats shall indicate the street name change on the affected plat and/or plats.
