Summary: The proposed request for the 2.01-acre Shapiro Property. The development was last approved by the Board of County Commissioner (BCC) on April 28, 2022 to abandon a Medical Office, with a subsequent Administrative Approval by the DRO for Business or Professional Office. The site is currently under construction as a Professional Office.

The request would allow for the development of a Medical Office. The Preliminary Site Plan indicates one 10,000 square foot (sq. ft.) structure, with a total of 65 parking spaces and access from Military Trail.
