Dear Contractor:

You are receiving this notification because you have been identified as a contractor who has applied for the Annual Decal Program (PBO-111) within the last twelve months from the Palm Beach County Building Division. Changes to Palm Beach County permitting and inspection processes are being implemented to facilitate contractor-friendly methods to complete required inspections.

We encourage you to take advantage of remote on-demand video inspections. This no-cost service uses your smartphone* and the free Video Inspection Pro app to initiate your residential water heater and HVAC change outs. There is virtually no waiting and your inspection occurs as work progresses on your job site.

Annual Permits With Random Inspections for Code Compliance Assurance (aka Decal Program) will be phased out by the end of 2024.**

With on-demand remote video inspection and self-issued permits for water heater and HVAC change outs, you are guaranteed to avoid rollovers, deficiencies are noted so your staff can make corrections while work is being performed to avoid costly removal and re-installation.

Remote video inspections allow your company to do the work and complete all required inspections the same day you start and finish your residential project.

Get started today:

- Download the free Video Inspection Pro app from your app store
- Complete the registration
- Within minutes, connect to a licensed inspector who will guide you through your inspection. (Your inspection is resulted in the ePZB portal.)

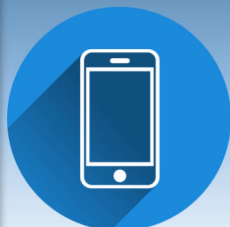

- ★ Plumbing - Sewer Connection

- ★ Plumbing – Water Heater Change Out within unit 1 & 2 Family– Like For Like
- ★ Reroofing - Single Family/Duplex/Single Family Attached (Townhouse)
- ★ Shutters
- ★ Siding
- ★ Solar Photovoltaic w/Electric Sub-Permit
- ★ Stucco on Lath
- ★ Tube Type Skylight
- ★ Water Heater Change Out—Electric Hardware – Like For Like (If sub-permit required)
- ★ Door – Overhead or Roll-up Replacement (Garage)
- ★ Window & Door Replacement (Impact - Residential)
- ★ Window & Door Replacement (Non Impact - Residential)

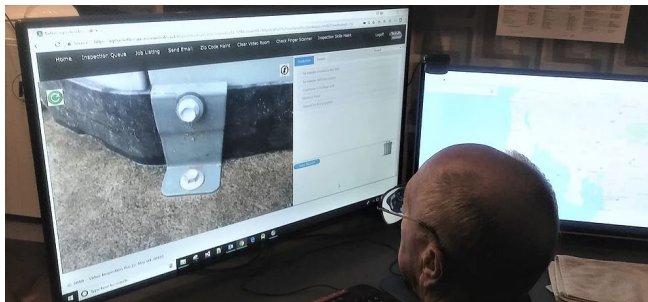


Inspections on Demand
