## EARLY POWER RELEASE REQUEST

of testing building systems, including air conditioning, light	nting, refrigeration, power and control circuits with the following stipulations:

- 1. No circuits will be left energized after all personnel have left the job without prior permission of the Building Division.
- 2. All panels and disconnects not in use will be locked in the "OFF" position or fuses will be removed.
- 3. Nothing will be energized without the permission of the electrical inspector.
- 4. The electrical equipment room will remain locked at all times with the key in the possession of the electrical contractor.
- 5. Final inspections for all trade permits/sub-permits must be scheduled and passed within 30 days.
- 6. OCCUPANCY OF THE BUILDING PRIOR TO C.O. IS PROHIBITED.
- 7. No furniture, racks, furnishings, or other personal or corporate property is permitted on site by this agreement.
- 8. No stocking of materials, other than those required for construction, is permitted by this agreement.
- 9. No on-site occupancy, use, or training of personnel employed by the occupant, tenant, business entity or owner is permitted by this agreement.
- 10. All structures (permanent and temporary) energized by this service must receive permit and required inspections. Energizing unpermitted structures may result in disconnection of the service.

Deviations from or violations of this agreement may result in immediate termination of the electrical power without further notice to owner, contractor or other affected parties. This form requires all of the signatures below prior to power being released.

The undersigned parties acknowledge and agree to abide by the stipulations listed above. The undersigned parties agree to hold Palm Beach County, its agents, employees, and elected officials harmless at all times from and against any and all damages that may arise as a result of the early release of power to the property referenced above. The undersigned parties hereby request power to be released for this project. This form does not guarantee power, which is at the discretion and control of the applicable utility company.
