This memo serves to notify interested County staff and related agencies of the deadlines for submittal, and tentative schedules for upcoming amendments to the Unified Land Development Code (ULDC). An informal meeting will be held on January 18, 2007, to summarize the amendment process and answer any questions. The meeting will be held at 2300 North Jog Road, in Room VC-1E-60 at 2:00 PM. The Zoning Division is proposing to undertake two rounds of amendments for 2007. The tentative schedules for both rounds are provided below:

- 1) Location in ULDC of proposed amendment (specific citation, title and page numbers required);
- A detailed description of the changes;
- 3) Where applicable, exact text to be struck-out, relocated or added;
- 4) The purpose, reason and justification for each amendment; and,
- 5) Verification that any interested or affected persons or organizations have been consulted during the initiation of the proposed amendment. Submittals should be transmitted in writing, with all required back up material attached.
