#### Temporary Moratorium

The Town of Loxahatchee Groves adopted a temporary Moratorium on November 20, 2007 and an extension on May 19, 2009, related to development within the town boundaries. Please review this ordinance prior to submitting any application to the Zoning Division to ensure compliance. #### Inter-Local/Fee

On July 10, 2007, the Board of County Commissioner entered into an Inter-local Agreement with Loxahatchee Groves to provide Zoning services for applications within the municipality.
