# Zoning Division Zoning Ordinance Nos. 2020-007, 2020-016, 2020-019, and 2020-020 ULDC Supplement 28

Supplement 28 of the Palm Beach County Unified Land Development Code (ULDC) codifies Ordinance No. 2019-007 (Landscape Service in the AR/RSA Zoning District and Access Requirements), which was adopted by the Board of County Commissioners (BCC) on May 28, 2020 with an effective date of June 10, 2020; Ordinance No. 2020-016 (Landscape Service in AGR-PUD Zoning District Preserve Areas), which was adopted by the BCC on July 30, 2020 with an effective date of August 3, 2020; and, Ordinance Nos. 2020-019 (Faith Farm and Split Zoning in the AGR-PUD) and 2020-020 (ULDC Round 2020-01 of Amendments), which were adopted by the BCC on August 27, 2020 with effective dates of September 3, 2020.

Staff is currently working on preparing the updates to the Adobe PDF and Web format versions of the ULDC. Staff anticipates the documents to be available to the public by September 30, 2020 on the Palm Beach County Zoning Division Web Page at the hyperlink below:
