SUNSHINE LAW

Chapter 286.011 (the Sunshine Law) requires that all work of Public Boards and Commissions take place in the Sunshine.

- 1. Meetings must be held after reasonable notice,
- 2. Meetings must be open to the public, and
- 3. Minutes of the meetings must be taken.

The Sunshine Law applies to any gathering of two or more members of the same board to discuss some matter which is reasonably foreseeable to come before that board for action. Penalties for violation

of the Sunshine Law

- 1. A violation of the Sunshine Law is a noncriminal infraction, punishable by a fine not to exceed \$500.
- 2. A person who is a **member of a board or commission** who **knowingly** violates the Sunshine Law is guilty of a misdemeanor of the second degree punishable as provided in s. 775.082 or 775.083. (**Imprisonment not exceeding 60 days or \$500 fine or both**).
- 3. Removal from office. The governor may suspend someone form their elected or appointed office who is charged with violating the Sunshine Law.
- 4. Attorneys fees may be assessed against the members of a board or commission found by a court to have violated the Sunshine Law unless the individual seeks and follows the advice of the board attorney prior to the alleged violation.
- 5. A court can void a resolution, rule, regulation or formal action taken by a government in violation of the Government in the Sunshine Law.

<u>Town of Palm Beach v. Gradison</u>, 296 So. 2d 473 (Fla. 1974) (town zoning ordinance was declared void because citizen committee established to assist in preparation of the ordinance violated the Sunshine Law).
