TITLE: an Official Zoning Map Amendment **REQUEST:** to allow a rezoning from the Agricultural Reserve (AGR) Zoning District to the Agricultural Reserve Planned Unit Development (AGR-PUD) Zoning District. **TITLE:** a Development Order Amendment **REQUEST:** to modify the Master Plan to add and delete land area (Preserves); amend a recorded Conservation Easement for Preserve Area No. 2; to allow the Partial Release of the Conservation Easement for Preserve Area No. 2; and, modify Conditions of Approval.

APPLICATION SUMMARY: Proposed is an Official Zoning Map Amendment and a Development Order Amendment (DOA) for the Canyon Lakes Agricultural Reserve Planned Unit Development (AGR-PUD). The 517-acre (ac.) development was first approved by the Board of County Commissioners (BCC) on April 24, 2003 for an Official Zoning Map Amendment from the Public Ownership and AGR to AGR-PUD Zoning District. A portion of the site was last approved by the BCC on August 27, 2020, for a rezoning from the Institutional and Public Facilities (IPF) and the AGR Zoning Districts to the AGR-PUD Zoning District; a DOA to modify the Master Plan to add and delete land area (Preserve); and, to amend Conditions of Approval.

The Applicant is proposing to modify the Preliminary Master Plan (PMP) to delete 26.69 acres (ac.) of Preserve Area (Preserve Areas #2 and #10), and to add 26.69 ac. of Preserve Area comprising six non-contiguous locations throughout the AGR Tier, which are proposed to be rezoned from AGR to the AGR-PUD Zoning District. The Applicant is also requesting to modify Planning Conditions of Approval related to the Preserve areas, to amend the Conservation Easement (Official Records Book 25867, Page 1437) for Preserve Area #2, and approval of the Partial Release of the aforementioned Conservation Easement.

This Application is being processed concurrently with two applications, as follows: an Official Zoning Map Amendment to rezone a 16.57-ac. portion of Hyder West (Z-2020-01699), and the 10.12-ac. site known as Pero (155th Lane Rezoning, Z-2020-01700). The PMP proposes no changes to the existing Development Area or to the overall acreage. Modifications are limited to the deletion and addition of Preserve Areas.

FINDINGS:

Official Zoning Map Amendment (Rezoning) to a PDD or TDD and Development Order Amendments:

When considering a Development Order application for a Development Order Amendment and/or a Rezoning to a Planned Development District (PDD), the BCC and ZC shall consider Standards a - h listed in ULDC Article 2.B.7.B.2, Standards. The Standards and Staff Analyses are indicated below. An Amendment that fails to meet any of these standards shall be deemed adverse to the public interest and shall not be approved.

a. Consistency with the Plan – The proposed use or amendment is consistent with the purposes, goals, objectives and policies of the Plan, including standards for building and structural intensities and densities, and intensities of use.

PLANNING DIVISION COMMENTS:

• *Consistency with the Comprehensive Plan:* The proposed use or amendment is consistent with the Goals, Objectives and Policies of the Comprehensive Plan, including previous Land Use Amendments, densities and intensities of use.

• *Relevant Comprehensive Plan Policies: FLUE* Policy 1.5.1-i.6 states that the preserve area shall consist of, at least, 60 percent of the gross acreage less right-of-way identified in the Thoroughfare Identification Map The policy also states that preserve areas for a 60/40 PUD shall contain a minimum contiguous area of 150 acres; or have a common boundary with other preserve properties whose aggregate total equals at least 150 acres and are contiguous to other preserve parcels or parcels designated Conservation (CON) on the Future Land Use Atlas (33-FLUE).

O Density & AGR Preserves: The subject request has a previous approval for 500 units on 517.001 acres (R-2018-1078) which was recently amended (DOA/PDD-2019-2394; R-2020-1243) to remove and replace 92.194 acres that reduced preserve P#2 Hyder and added 10 new preserves. The current application seeks to further reduce P#2 Hyder from 35.661 acres to 19.093 acres, remove and replace the 10.119-acre Preserve #10 (Pero) and add 6 new preserves for a total of 26.687 acres being exchanged. In addition, several of the new preserves are associated with the Nursery with Landscape Services Ordinance ORD. 2020-16 (P10; P18; P19; P20), and others have Farm Residence letters (P9; P11-P18).

The proposed preserves that support, or may support, Nursery with Landscape Service uses will have to be approved in the applicable Zoning process and demonstrate consistency with the requirements as laid out within the ULDC for those uses. Exhibit B within Ordinance 2020-016 does not provide substantive proof that the proposed landscape services meet the requirements laid out in the new ULDC language, rather the indicated percentages were preliminary studies made by Staff to determine if the proposed 70/30 regulations could work before returning to the BCC for direction on the regulations. They were based on an analysis of the aerial photography and were not ground-truthed, nor field verified. At best, they were an example of how a project could comply, but do not guarantee nor do they demonstrate that a project complies with the regulations. The following proposed preserves will require a companion application in the Development Review Officer (DRO) process after the BCC approves their designation as preserve parcels:

There are two companion rezoning applications to take the lands removed from preserve status and rezone them back to Agricultural Reserve (AGR) Zoning designation as follows:

- 1. Hyder West AGR (Z-2020-1699): 16.568 acres was P2 Hyder; and,
- 2. 155 Lane Rezoning (Z-2020-1700): 10.119 acres was P10 Pero

The Applicant is not seeking to increase the dwelling units with this request. In addition, the Applicant has requested to modify conditions of approval related to the added lands areas and timing of commitments.

60/40 Development Option: Per Policy 1.5.1-i. the Applicant is required to provide a minimum of 60% of preserve area and 40% maximum developable area. The Preserve areas are not required to be contiguous with the development area. The 60/40 breakdown is as follows:

Modification of Conditions and Release of Easements: The exchange of AGR preservation areas will require that the Conservation Easement for P2 Hyder to be released and rerecorded, while the new preserves 18-22 will require that new AGR Conservation Easements are recorded prior to April 1, 2022 or Final approval by the Development Review Officer. The modification of existing Planning condition #8 will be necessary to address the preserve parcel amendments and additions from this request. The partial release of the AGR Conservation Easement for P2 Hyder is necessary due to the reconfiguring of the P2 Hyder Preserve.

• Special Overlay District / Neighborhood Plan / Planning Study Area: The subject property is located within the boundaries of the West Boynton Area Community Plan, which is administered by the Coalition of Boynton West Residents Association (COBWRA). The subject request is not inconsistent with the neighborhood plan. The Applicant was advised to meet with the neighborhood group responsible for implementing the Neighborhood Plan. No letters in support or objection have been received as of the writing of this report.

b. Consistency with the Code - The proposed use or amendment is not in conflict with any portion of this Code, and is consistent with the purpose and intent of this Code.

The proposed amendment to the Preserve Areas of Canyon Lakes AGR-PUD complies with all applicable standards of this Code for use, layout, function, and general development characteristics. No changes are proposed for neither the Development Area nor the remaining Preserve Areas #1, #3-9 and #11-17, which were all previously found to be consistent with the Code. The amendment to swap 26.69 acres of Preserve Area out for the equal amount of land is consistent with the Code and the prior approval for the purposes of density. In addition, the overall PUD complies with Article 3.E.2.B.2, Required Performance Standards, as previously approved and built. The new Preserve Areas associated with this application meet or exceed the requirements noted in Article 3.E.2.F.3, Preserve Area, including location, access, and uses. The Applicant submitted a separate "Legal Lot of Record Analysis" for proposed Preserve Parcels #10 and #18 through #22.

Preserve Area #2 is 35.67 acres, owned by G.L. Homes of Palm Beach Associates and is encumbered by a Conservation Easement (ORB 24867 Pg. 1437). The Applicant is proposing to remove 16.57 acres from the Master Plan, and Conservation Easement, and rezone that portion in a concurrent application, Z-2020-01699, Hyder West rezoning. The remaining 19.12 acres of Preserve Area #2 will remain as Canyon Lakes AGR-PUD.

Proposed Preserve Area #9, AKD, is an 11.44-acre portion of a 17.29-acre site in the AGR Zoning district that currently supports an equestrian use. It is important to note that a 4.70-acre portion of the site was recently approved for a rezoning from the AGR to the AGR-PUD Zoning District to serve as a Preserve Area for Valencia Cove AGR-PUD (Control No. 2004-00369). There is, however, no overlap between the two areas. There is one acre reserved as the farm residence, for which the Applicant provided a Farm Residence Determination Letter from the Planning Division dated October 3, 2018.

Proposed Preserve Areas #10 through #17 are all within the AGR Tier and support either Bona-Fide Agriculture or Nurseries. Each of the properties were issued Farm Residence Letters by the Planning Director and according to the Applicant's Justification Statement, non-permitted structures and/or uses not permitted within an AGR-PUD Preserve or Conservation Area, i.e. damaged, abandoned, trailers, will be removed prior to the recordation of the Conservation Easements.

c. Compatibility with Surrounding Uses – The proposed use or amendment is compatible and generally consistent with the uses and character of the land surrounding and in the vicinity of the land proposed for development.

There are no proposed changes to neither the Preserve Areas, nor the Development Area with this
amendment. The Development Area was determined to be compatible with surrounding uses with

the approval of R-2015-0011 in January of 2015, and with the Preserve Areas to be added simply being a continuation of the existing agricultural uses, as intended to be accommodated within an AGR-PUD Preserve Area, Staff's determination of compatibility remains the same.

d. Design Minimizes Adverse Impact – The design of the proposed use minimizes adverse effects, including visual impact and intensity of the proposed use on adjacent lands.

This DOA and rezoning propose no physical changes to the Development Area or the Preserve Areas. Therefore Staff does not anticipate any adverse impact to the adjacent lands.

e. Design Minimizes Environmental Impact – The proposed use and design minimizes environmental impacts, including, but not limited to, water, air, storm water management, wildlife, vegetation, wetlands and the natural functioning of the environment.

ENVIRONMENTAL RESOURCE MANAGEMENT COMMENTS: VEGETATION PROTECTION: The site is existing commercial development.

WELLFIELD PROTECTION ZONE: The property is not located within a Wellfield Protection Zone.

IRRIGATION CONSERVATION CONCERNS AND SURFACE WATER: All new installations of automatic irrigation systems shall be equipped with a water sensing device that will automatically discontinue irrigation during periods of rainfall pursuant to the Water and Irrigation Conservation Ordinance No. 93 3. Any non stormwater discharge or the maintenance or use of a connection that results in a non stormwater discharge to the stormwater system is prohibited pursuant to Palm Beach County Stormwater Pollution Prevention Ordinance No. 93 15.

ENVIRONMENTAL IMPACTS: There are no significant environmental issues associated with this petition beyond compliance with ULDC requirements.

f. Development Patterns – The proposed use or amendment will result in a logical, orderly and timely development pattern.

This determination was made previously with the approval of R-2015-0011 in January of 2015 and this DOA proposes no changes to the Development Area. Therefore, Staff's determination remains the same.

g. Adequate Public Facilities – The extent to which the proposed use complies with Art. 2. F, Concurrency.

ENGINEERING COMMENTS: There are no proposed engineering conditions at this time.

PALM BEACH COUNTY HEALTH DEPARTMENT: This project has met the requirements of the Florida Department of Health.

FIRE PROTECTION: Staff has reviewed this application and have no comment.

SCHOOL IMPACTS: Staff has reviewed this application and have no comment.

<u>PARKS AND RECREATION</u>: The Parks and Recreation Department has "no comment" on the preserve parcel swap.

h. Changed Conditions or Circumstances – There are demonstrated changed conditions or circumstances that necessitate a modification.

As mentioned above, the Applicant has purchased the development rights from the six proposed Preserve Areas, and this amendment is necessary in order to remain consistent with the approval as an AGR-PUD utilizing the 60/40 development regulations. Staff has reviewed this request and finds the justification adequate to necessitate the amendment.

CONCLUSION: Staff has evaluated the standards listed under Article 2.B. and determined that thereis a balance between the need for change and the potential impacts generated by this change. Prior to or concurrent with recordation of the plat for the developable area as identified in Petition No. 2002-067, for all of the Preserve parcels, the applicant shall either: I) dedicate these lands to Palm Beach County; 2) record a restrictive covenant in a form acceptable to the Palm Beach County Attorney for these subject parcels; or 3) subject these parcels to a conservation easement, limiting these sites to Agricultural Reserve preserve areas in accordance with the Agricultural Reserve preserve provisions of the Comprehensive Plan. 20. Prior to the issuance of the certificate of occupancy for the primary-recreation building on the 4.0+ acre recreation site, the petitioner shall mulch or pave the pedestrian trail shown fronting the recreation area on the certified PDP dated February 18,2003. e. Wetland restoration and maintenance, or bona fide agriculture as defined by the Code; and

f. Those other activities authorized within a Preservation Area under Table 3.E.1. B of the Code and consistent with applicable provisions of the Comp Plan.

2. Prohibited Uses. Any use of or on the Property that is not specifically listed or included in Section 1, above, or that is inconsistent with agricultural, environmentally significant uplands or wetlands, or open space preservation is prohibited. (DRO/ONGOING: PLANNING - Planning) [Note: COMPLETED] (Previous PLANNING Condition 22 of Resolution R-2020-1243, Control No.2002-00067)

23. Prior to or concurrent with the plat for the Fogg North PUD, the conservation easement for the 100' Lyons Road Rural Parkway Preserve Area shall be recorded, as approved by the County Attorney's Office, the Engineering Department, and the Planning Division. The conservation easement for the 100 foot Lyons Road Rural Parkway Preserve Area shall contain:

a. A Rural Parkway Conceptual Landscape Plan that conforms with the preliminary Rural Parkway Conceptual Landscape Plan received by the Planning Division on March 18, 2003, previously presented to Planning Staff, to include but not be limited to the following items:

i. Flowering trees;

ii. Undulating berms, no taller than five feet and landscaped with native vegetation; and

iii. Benches/pedestrian gathering area. One (1) pedestrian gathering area shall be provided within the 100-foot wide Lyons Road Rural Parkway along this project frontage.

b. The Rural Parkway easement shall not include:

i. Walls;

ii. No structures shall be allowed in the Rural Parkway Easement with the exception of a bus shelter and benches/pedestrian gathering area.

c. The Rural Parkway easement may include:

i. A ten (10) foot utility easement located adjacent to the Lyons Road right-of-way and a bus easement;

ii. Other drainage/utility easements may only be permitted which transverse (run perpendicular to) the Lyons Road Rural Parkway Easement to place drainage/utilities in the developable portion of the PUD.

iii. Other drainage easements may be permitted in the Rural Parkway Easement for the purposes of draining the Rural Parkway subject to approval by the County Engineering Department and the Planning Division.

d. A maintenance agreement for continual maintenance of the Rural Parkway that will contain language allowing for the transfer of maintenance to the Homeowners Association or; a deed to the County for the County's ownership and maintenance.

e. Title insurance for these easements shall be provided to Palm Beach County subject to approval by the County Attorney and in an amount acceptable to the Department of Environmental Resources Management and the Planning Division.

f. Should the 100-foot wide Lyons Road Rural Parkway conservation easement not be placed on this property in a form acceptable to the County Attorney, Engineering Department, and Planning Division, then the approval of this Development Order (DO) shall be scheduled for review by the Board of County Commissioners with a recommendation by staff to revoke the Development Order. (ONGOING: PLANNING - Planning) [Note: COMPLETED] (Previous PLANNING Condition 23 of Resolution R-2020-1243, Control No.2002-00067)

SCHOOL BOARD

1. Prior to final DRC certification of the site plan, the petitioner shall revise the site plan to label the school bus stop, turnaround and bus shelter and shall be approved by the School Board. (DRO: SCHOOL BOARD - School Board) [Note: COMPLETED] (Previous SCHOOL BOARD Condition 1 of Resolution R-2020-1243, Control No.2002-00067)

2. The property owner shall place a notice of annual boundary school assignments for students from this development. The District will provide an 11" X 17" sign to be posted in a clear and visible location in all sales offices and models with the following:

"Notice to Home Buyers/Tenants"

b. The Revocation of the Official Map Amendment, Conditional Use, Requested Use, Development Order Amendment, and/or any other zoning approval; and/or

c. A requirement of the development to conform with the standards of the Unified Land Development Code at the time of the finding of non-compliance, or the addition or modification of conditions reasonably related to the failure to comply with existing Conditions of Approval; and/or








Figure 4 – Preliminary Master Plan (PMP-1), dated February 8, 2021




Figure 5 – Preliminary Regulating Plan (PRP-1), dated February 8, 2021




Figure 6 – Preliminary Regulating Plan (PRP-2), dated February 8, 2021


