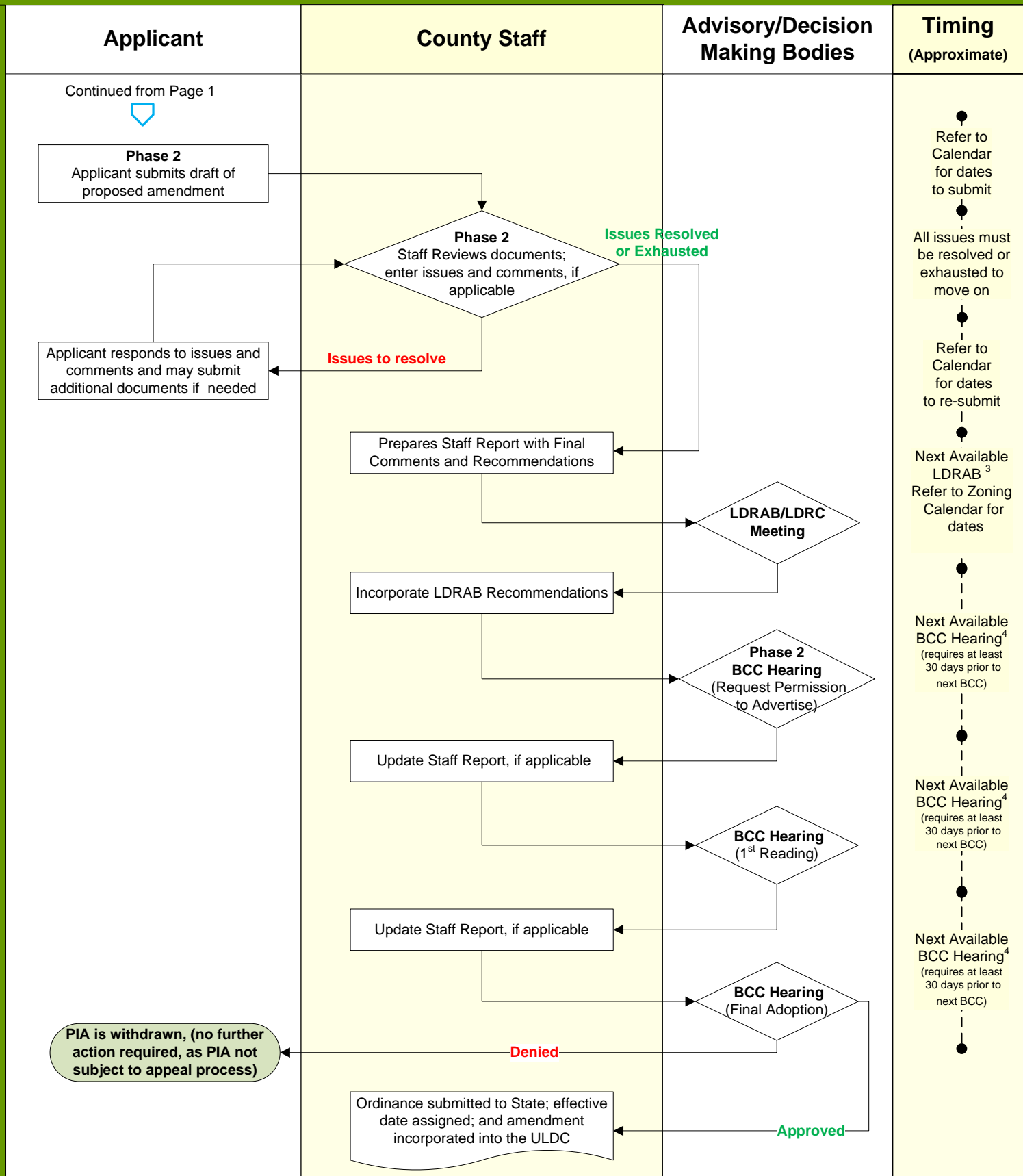

- Notes:**
- PIA may be insufficient if not meeting all standards established in ULDC Art.2.D.3.A thru F, and as described in the Technical Manual;
 - The Applicant may address all insufficiencies within 30 calendar days of the insufficiency notice. A written request for an extension may be submitted within 5 days of the 2nd Notification of Insufficiency; if no extension is requested and granted then the application is automatically withdrawn;
 - A minimum of 15 working days is required prior to next scheduled Land Development Regulation Advisory Board (LDRAB) and Land Development Regulation Commission (LDRC) meetings to ensure placement on the Agenda.
 - Number of BCC Hearings depends on the request(s) and compliance with Florida Statutes for publication notification.
