ZONING RESOLUTION NO. R-71-298 MODIFYING THE DISTRICT BOUNDARIES

ADOPTED AUGUST 19, 1971

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, in regular session assembled this the 19th day of August, 1971 adopted as an Amendment to Zoning Resolution No. 3-57, pursuant to the authority vested in said Commission by Chapter 57-1691, Special Laws of Florida 1957, and Chapter 59-1686, Special Laws of Florida 1959, Chapter 70-863, Special Laws of Florida 1970:

That portion of the Southeast 1/4 of Section 14, Township 47 South, Range 42 East, described as follows: commence at the Southeast corner of said Section 14; thence South 880 44' 00" West along the South Boundary of Section 14, a distance of 2,503. 18 feet to the East right-of-way line of State Road No. 808 (a 100 foot right-of-way); thence North 00° 04' 00" East along said right-of-way line, a distance of 496.66 feet to the point of beginning of land herein to be described; thence continuing along the last mentioned course, a distance of 350.0 feet; thence South 87° 50' 24" East, a distance of 200.0 feet; thence North 00° 04' 00" East, a distance of 202.55 feet to the South right-of-way of Boca Raton West Road (as shown on Palm Beach County, Florida, Engineering Department Job 65-128, Drawing No. 3-65-023, dated March 19, 1965, showing a 106 foot right-ofway); thence Easterly along said South right-of-way line on a curve to the left, radius of 2, 917. 93 feet, central angle of 2° 07' 34", an arc distance of 108. 28 feet; thence South 87° 50' 24" East tangent to said curve, a distance of 105.58 feet to a point of curve; thence along said curve to the left, radius of 5, 782. 96 feet, central angle of 0° 45' 15", an arc distance of 76. 12 feet; thence South 88° 35' 39" East, tangent to said curve, a distance of 110.03 feet; thence South 00° 04′ 00" West, a distance of 550.0 feet; thence North 87° 50′ 24" West, a distance of 599.51 feet to the point of beginning is hereby rezoned from A-1 Agricultural District to C-1 Neighborhood Commercial District.
