ZONING RESOLUTION NO. R-71-457

MODIFYING THE DISTRICT BOUNDARIES

ADOPTED November 18, 1971

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, in regular session assembled this the 18th day of November 1971, adopted as an Amendment to Zoning Resolution No. 3-57, pursuant to the authority vested in said Commission by Chapter 57-1691, Special Laws of Florida 1957, Chapter 59-1686, Special Laws of Florida 1959, and Chapter 70-863, Special Laws of Florida 1970:

A parcel of Land in Section 7, Township 44 South, Range 43 East, being more particularly described as follows: Commencing at the North 1/4 corner of said Section 7, run thence South 03° 07' 57" East along the North-South centerline of said Section 7, a distance of 560.74 feet; thence run South 89° 49' 30" West a distance of 839. 12 feet; thence South 03° 07' 57" East a distance of 200. 27 feet to the Point of Beginning of the herein described Parcel of Land; run thence South 03° 07' 57" East a distance of 788.48 feet; thence South 86 ° 52' 03" West a distance of 385.00 feet; thence North 630 07' 57" West a distance of 130.00 feet; thence South 86° 52' 03" West a distance of 150.00 feet; thence North 45° 12' 47" West a distance of 92.62 feet; thence North 78° 07' 13" West a distance of 110.00 fcet; thence South 86° 52' 47" West a distance of 150.00 feet; thence North 03° 07' 13" West a distance of 876.37 feet; thence North 890 49' 30" East a distance of 526. 42 feet; thence South 030 07' 57" East a distance of 200. 27feet; thence North 89° 49' 30" East a distance of 440. 59 feet to the Point of Beginning is hereby rezoned from R-1 Single Family Dwelling District to R-2A Multiple Family Dwelling District.
