RESOLUTION APPROVING OFFICIAL ZONING MAP  
AND CONVERSION CHART

WHEREAS, the Palm Beach County Planning Commission, pursuant to Chapter 163, Florida Statutes, is authorized to enact or amend and enforce a zoning ordinance; and

WHEREAS, the former Palm Beach County Zoning Code, being Resolution 3-57, as amended, established zoning districts as depicted in the Official Zoning Map of Palm Beach County and Zoning Map Sheets, which are incorporated herein, made a part hereof as though fully set forth; and

WHEREAS, the Palm Beach County Zoning Code Ordinance of 1972 establishes zoning districts, requiring a conversion from existing zoning districts to the newly created and designated zoning districts; and

WHEREAS, the Palm Beach County Planning Commission is desirous of adopting the Official Zoning Map and Zoning Map Sheets and the Official Zoning District Conversion Chart, attached hereto and made a part hereof as though fully set forth herein.

NOW, THEREFORE, BE IT RESOLVED BY THE PLANNING COMMISSION OF PALM BEACH COUNTY, FLORIDA, that:

Section 1. The Commission finds the foregoing recitals to be true.

Section 2. ~~The Official Zoning Map of Palm Beach County, together with~~ Official Zoning Map Sheets Nos. 1 to 56 inclusive; 58, 60 to 64 inclusive; 66, 68 to 71 inclusive; 75, 76, 85, 86, 91, 101, 102, 107, 118, 171, 181 to 183 inclusive; 200 to 204 inclusive; 217 to 220 inclusive; 236, 251, 252 and 167, incorporated by reference as though fully set forth and included herein are approved and adopted.

Section 3. The Official Zoning District Conversion Chart, incorporated by reference as though fully set forth and included herein, is approved and adopted.

Section 4. The Official Zoning Map of Palm Beach County, Zoning Map Sheets numbered as heretofore indicated, and the Official Zoning District Conversion Chart, as all adopted, shall be a part of the permanent records of the Planning Commission of Palm Beach County, Florida.

Section 5. The Chairman and Secretary are authorized to execute the within resolution.

Section 6. This resolution is hereby made a part of the Palm Beach County Zoning Code as though incorporated therein by reference.

The foregoing resolution was offered by Planning Commissioner Eassa, who moved its adoption. The motion was seconded by Planning Commissioner Altman, and upon being put to a vote, the vote was as follows:
