ZONING RESOLUTION NO. R-72-37

MODIFYING THE DISTRICT BOUNDARIES

ADOPTED January 20, 1972

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, in regular session assembled this the 20th day of January 1972, adopted as an Amendment to Zoning Resolution No. 3-57, pursuant to the authority vested in said Commission by Chapter 57-1691, Special Laws of Florida 1957, Chapter 59-1686, Special Laws of Florida 1959, and Chapter 70-863, Special Laws of Florida 1970:

Beginning at the Northwest corner of Section 24, Township 45 South, Range 42 East; thence South $0^{\circ} 17' 54''$ West along the West line of said Section 24, a distance of 460.18 feet to a point; thence South $89^{\circ} 50' 08''$ East, a distance of 50.00 feet to a point in the East right-of-way line of Military Trail (S. R. 809) and the point of beginning; thence continue South $89^{\circ} 50' 08''$ East, a distance of 200.00 feet to a point; thence South $0^{\circ} 17' 54''$ West, a distance of 200.00 feet to a point; thence North $89^{\circ} 50' 08''$ West, a distance of 200.00 feet to a point in the East right-of-way of Military Trail (S. R. 809); thence North $0^{\circ} 17' 54''$ East along the said East right-of-way line of Military Trail (S. R. 809), a distance of 200.00 feet to the point of beginning is hereby rezoned from A-1 Agricultural District to C-1A Limited Commercial District.

The foregoing resolution was offered by Commissioner

Warren, who moved its adoption. The motion was seconded by Commissioner Johnson, and upon being put to a vote, the vote was as follows:

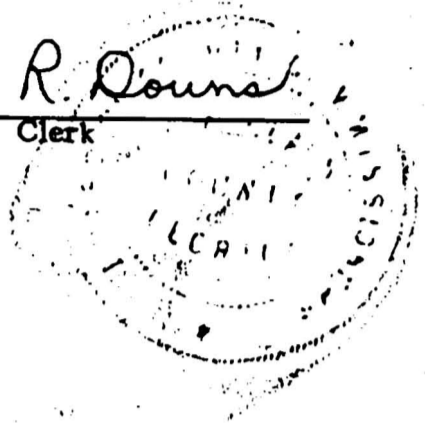
The Chairman thereupon declared the resolution duly
