ZONING RESOLUTION NO. R-72-150
MODIFYING THE DISTRICT BOUNDARIES

ADOPTED March 16, 1972

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, in regular session assembled this the 16th day of March 1972, adopted as an Amendment to Zoning Resolution No. 3-57, pursuant to the authority vested in said Commission by Chapter 57-1691, Special Laws of Florida 1957, Chapter 59-1686, Special Laws of Florida 1959, and Chapter 70-863, Special Laws of Florida 1970:

Being a tract of Land in Sections 28, 29, 32 and 33, Township 43 South, Range 42 East, and more particularly described as follows: Tracts 16, 17, and 18, less the North 446 feet thereof, as measured at right angles to the North line of Tracts 16, 17, and 18; Tract 19, less the West 200 feet of the North 446 feet, as measured at right angles to the North line of Tract 19; and Tract 20; all in Block 1, Palm Beach Farms Company Plat No. 9, as recorded in Plat Book 5, Page 58; subject to Lake Worth Drainage District Canal Right-of-way over the North 46 feet of said Tracts 19 and 20; and the following parcels lying and being in Block 3, Palm Beach Farms Company Plat No. 3, as recorded in Plat Book 2, Page 45 and more particularly described as follows: The West 1/2 of tract 1, all of tracts 2, 3, 4 and 5, and the South 1/2 of tract 6, less the South 8 feet of said tract 6 and all of tracts 8 and 9; and the East 1/2 of tract 10, and that part of tract 10 lying West of the East 890 feet of tract 10; less the North 51 feet of said tracts 8, 9 and 10 for Lake Worth Drainage District Right-of-way; and the East 550 feet of tract 11 and that part of tract 11 lying west of the East 890 feet of tract 11, and the West 1/2 of tract 12, and the West 1/2 of tract 13, and the East 1/2 of tract 17, and the East 550 feet of tract 18 and that part of tract 18 lying West of the East 890 feet of tract 18, subject to the Right-of-way of Belvedere Road over the South 33 feet of tracts 17 and 18; is hereby rezoned from A-1 Agricultural District to R-1A Single Family Dwelling District.
