

RESOLUTION NO. R-73- 563

RESOLUTION DENYING ZONING PETITION

WHEREAS, the Board of County Commissioners, as the governing body, pursuant to the authority vested in Chapter 163 and Chapter 125, Florida Statutes, and Chapter 70-863, Laws of Florida, Special Acts of 1970, is authorized and empowered to consider petitions relating to zoning; and

WHEREAS, the notice and hearing requirements as provided for in Chapter 402.5 of the Palm Beach County Zoning Code Ordinance No. 73-2 have been satisfied; and

WHEREAS, Petition No. 73-70 was presented to the Board of County Commissioners of Palm Beach County at its public hearing conducted on 23 August 1973.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, assembled in regular session this 23rd day of August, 1973, that petition No. 73-70, the petition of CLYDE ROBERTS for the REZONING, FROM AGRICULTURAL DISTRICT TO IG-GENERAL INDUSTRIAL DISTRICT AND THE FURTHER SPECIAL EXCEPTION TO ALLOW A SEPTIC TANK SERVICE, OFFICE AND DISPATCH INCLUDING CASTING AND STORAGE OF CONCRETE SEPTIC TANKS AND COMPONENTS on the East 1/2 of the West 1/2 of Tracts 14 and 15, Subdivision of the Southwest 1/4 of the Southwest 1/4 of Section 36, Township 44 South, Range 42 East as recorded in Plat Book 3, page 10; reserving 100 feet for State Road right-of-way on the North line of the centerline and the North 40 feet of the above described parcel for County road right-of-way. Said property located on the north side of Lantana Road (S.R. 812) approximately .4 mile west of Military Trail (S.R. 809), was denied as advertised.

The foregoing resolution was offered by Commissioner Johnson , who moved its adoption. The motion was seconded by Commissioner Culpepper , and upon being put to a vote, the vote was as follows:
