## RESOLUTION DENYING ZONING PETITION

WHEREAS, the Board of County Commissioners, as the governing body, pursuant to the authority vested in Chapter 163 and Chapter 125, Florida Statutes, and Chapter 70-863, Laws of Florida, Special Acts of 1970, is authorized and empowered to consider petitions relating to zoning; and

Smith, Jr., Agent, and Michall Morton, President, for the REZONING, ROM AG-AGRICULTURAL DISTRICT TO RM-RESIDENTIAL MULTIPLE FAMILY DISTRICT (MEDIUM DENSITY) AND THE FURTHER SPECIAL EXCEPTION TO ALLOW A PLANNED UNIT DEVELOPMENT on the West 1127.70 feet of the Northeast 1/4 of Section 34, Township 44 South, Range 42 East, less the West 40 feet for County Road purposes, and less the L.W.D.D. Lateral Canal rightof-way as now laid out and in use; and less'that part of the Northwest 1/4 of the Northeast 1/4 of Section 34, Township 44 South, Range 42 East, lying North of the right-of-way of said L.W.D.D.
