

RESOLUTION NO. R-73-638

RESOLUTION APPROVING ZONING PETITION

WHEREAS, the Board of County Commissioners, as the governing body, pursuant to the authority vested in Chapter 163 and Chapter 125, Florida Statutes, and Chapter 70-863, Laws of Florida, Special Acts of 1970, is authorized and empowered to consider petitions relating to zoning; and

WHEREAS, the notice and hearing requirements as provided for in Chapter 402.5 of the Palm Beach County Zoning Code Ordinance No. 73-2 have been satisfied; and

WHEREAS, Petition No. 73-177 was presented to the Board of County Commissioners of Palm Beach County at its public hearing conducted on 28 September 1973.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, assembled in regular session this 28th day of September, 1973, that petition No. 73-177, the petition of the CENTRAL & SOUTHERN FLORIDA FLOOD CONTROL DISTRICT by Edward Dale, Executive Director, for the REZONING, FROM AG-AGRICULTURAL DISTRICT TO PC-PRESERVATION/CONSERVATION DISTRICT of a tract of land lying in Section 14, Township 46 South, Range 41 East more particularly described as that portion of Tracts 5, 7, 8, 10, 15 and 18, lying East of Levee 40 and Tracts 9, 16 and 17 and 23, less the South 75 feet, and Tract 24 less the South 75 feet, Block 66, Palm Beach Farms Company Plat No. 3; also less the right-of-way for Canal S-11 and Lateral 33W. Said property located on the east side of Levee L-40 approximately three (3) miles north of the extension of Clint Moore Road, was approved as advertised.

The foregoing resolution was offered by Commissioner **Warren** , who moved its adoption. The motion was seconded by Commissioner Johnson , and upon being put to a vote, the vote was as follows:
