

RESOLUTION NO. R-73 -714

RESOLUTION APPROVING ZONING PETITION

WHEREAS, The Board of County Commissioners, as the governing body, pursuant to the authority vested in Chapter 163 and Chapter 125, Florida Statutes, and Chapter 70-863, Laws of Florida, Special Acts of 1970, is authorized and empowered to consider petitions relating to zoning; and

WHEREAS, the notice and hearing requirements as provided for in Chapter 402.5 of the Palm Beach County Zoning Code Ordinance No. 73-2 have been satisfied; and

WHEREAS, Petition No. 73-198 was presented by the Board of County Commissioners of Palm Beach County at its public hearing conducted on 25 October 1973.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, assembled in regular session this 25th day of October, 1973, that petition No. 73-198, the petition of THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY by Lake Lytal, Chairman, for the REZONING, FROM AG-AGRICULTURAL DISTRICT TO PO-PUBLIC OWNERSHIP DISTRICT of Tracts 41 and 42, Block 14, Tracts 49 through 58 inclusive, Block 15, Tracts 4, 5, 12, 13, 20, 21 and 28 through 38 inclusive, Block 21, less the right-of-way for Forest Hill Boulevard, Palm Beach Farms Company Plat No. 3 in Sections 8, 9, 17, 20, 21 and 22, Township 44 South, Range 42 East as recorded in Plat Book 2, page 47. Said property is bounded on the north by Forest Hill Boulevard, on the west by Florida's Turnpike and on the south by L.W.D.D. Lateral Canal No. 10, containing 382 acres, more or less, was approved as advertised.

The foregoing resolution was offered by Commissioner Culpepper , who moved its adoption. The motion was seconded by Commissioner Weaver , and upon being put to a vote, the vote was as follows:
